## PROBABLE CAUSE

On the above date and time, I was patrolling Palm Beach County in my marked patrol vehicle. I was traveling southbound on Dixie Highway, when I observed a gray in color small vehicle in the outside travel lane. I noticed the vehicle was slightly weaving within its lane. I continued to follow the vehicle southbound, on Dixie Highway. The gray vehicle then changed lanes from the outside travel lane, into the outside travel lane without activating the vehicles turn signal. The vehicle then made a left turn onto State Road 882 (Forrest Hill Blvd). I then activated my emergency lights and sirens to initiate a traffic stop on the vehicle. Shortly after, the gray vehicle came to a controlled stop on the right shoulder on Forrest Hill Blvd. I then observed the vehicle to be a Gray Porsche, bearing Florida License Plate "350NJG". I then exited my patrol vehicle and approached the Gray Porsche on the driver side. Once to vehicle, I observed a white female driver; who was later identified by her Florida Driver's License E-212-798-66-942-0 Sharagay Esposito. I introduced myself to Ms. Esposito and explained the reason for the traffic stop. I then asked Ms. Esposito for her Florida Driver's License. Ms. Esposito advised me that she did not have her license with her at the time. While speaking I observed an unknown alcoholic beverage coming from inside the vehicle. I then asked Ms. Esposito if she has had any alcoholic beverages tonight before driving. Ms. Esposito advised me no, then advised me yes she did. I asked Ms. Esposito how many drinks she had. Ms. Esposito advised me that she had 3 glasses of wine. I then advised Ms. Esposito to exit the vehicle. Once out of the vehicle, Ms. Esposito was observed to have a moderate odor of an unknown alcoholic beverage coming from her mouth and breathe area while speaking with me. Ms. Esposito was slow to respond to questions. Ms. Esposito was also observed to have:

- Bloodshot eyes
- Slurred speech
- Slow and lethargic movements

When asked, Ms. Esposito agreed to submit to a series of field sobriety exercises.

## Horizontal Gaze Nystagmus exercise

Prior to beginning the exercise it was determined Ms. Esposito was wearing contacts. Ms. Esposito's eyes were checked and her eyes displayed equal tracking and her pupils were equal sizes. Ms. Esposito was instructed to following the stimulus with her eyes only, keeping her head still. After stating she understood the instructions Ms. Esposito attempted this exercise.

The results of this exercise displayed 5 of the 6 possible clues.

- A lack of Smooth Pursuit in her left eye.
- A lack of Smooth Pursuit in her right eye.
- A distinct and sustained nystagmus in the left eye at maximum deviation.
- An onset of nystagmus in the left eye prior to 45 degrees.
- An onset of nystagmus in the right eye prior to 45 degrees.

While performing the Horizontal Gaze Nystagmus exercise, it was observed that Ms. Esposito:

- Had difficulty following and responding to instructions.
- Moved her head from side to side during the exercise.
- Swayed while standing.
- The instructions for the exercise had to be repeated

## Walk and Turn exercise

Prior to attempting this exercise, Ms. Esposito indicated she did not have any medical problems that would have prevented her from performing the exercise. Ms. Esposito was instructed to put her left foot on the line and her right foot in front of it with her right heel touching the toe of her left foot. She was instructed to stand in this manner with her hands to his sides until the exercise instructions were completed and the exercise demonstrated. Ms. Esposito was instructed not to begin the exercise until told to start. She was instructed to take nine steps along the line in a heel-to-toe manner. After the ninth step she was to stop and turn around keeping her lead foot on the ground, taking several small steps with the other foot to turn around. After turning around she was to take nine steps in a heel-to-toe manner back along the line, in the direction she had come from. Ms. Esposito was further instructed to watch her feet at all times while walking, keep her arms down to his side, and to count her steps out loud. After the exercise was demonstrated, Ms. Esposito stated she understood the instructions and was instructed to begin the exercises.

- After attempting the Walk and Turn exercise displayed 1 of 8 possible clues.

## Walk and Turn exercise observations:

- On the first set of steps Ms. Esposito failed to walk in a heel-to-toe manner on 5 steps, failing to walk heel-to-toe on steps 2, 4, 6, 8, and 9. - On the second set of steps Ms. Esposito failed to walk in a heel-to-toe manner on 5 steps, failing to walk heel-to-toe on steps 2, 3, 4, 5, and 6.

# One Leg Stand exercise

Prior to attempting this exercise, Ms. Esposito indicated she did not have any medical problems that would have prevented her from performing the exercise. Ms. Esposito was instructed to stand with her heels together and hands down to her sides while the instructions were given and during the exercise. Ms. Esposito was instructed not to begin the exercise until she was instructed to start, and after the exercise had been demonstrated. When instructed to start, she was to raise the foot of her choice off the ground approximately 6 inches. While her leg was raised she was to keep her leg straight, watch her raised foot, and to count out loud by thousands (one thousand one, one thousand two, one thousand three...) and to continue the exercise until told to stop (30 seconds). After this exercise was demonstrated and indicating she understood the instructions Ms. Esposito attempted this exercise

When Ms. Esposito attempted this exercise she raised his right foot.

The result of this exercise displayed 3 of the 4 possible clues.

During this exercise, Ms. Esposito:

- Swayed during the exercise.
- Used arms for balance.
- Put her foot down (2 time(s) during the exercise).

Ms. Esposito also raised her right foot, counted to 5 seconds then placed that foot back on the ground. Then raised her left foot, and counted to 5 seconds.

Additionally, during the One Leg Stand exercise, Ms. Esposito was observed to:

- End the exercise before she was told to put her foot down. (She was to keep her leg raised for 30 seconds). Ending the exercise at the count of 5.
- Fail to watch her raised foot during the exercise as instructed.
- Fail to keep her raised leg straight.

After I completed the Standardize Field Sobriety Exercise observations on Ms. Esposito, I then placed Ms. Esposito under arrest for suspected driving under the influence (DUI) of alcohol. I then placed Ms. Esposito in the rear of my patrol vehicle, and secured her in. Shortly after, I departed the scene enroute to the Palm Beach County Jail. Upon arrival at the jail, I escorted Ms. Esposito to the BAT center. There, I conducted a 20 minute observation period of Ms. Esposito. Once the 20 minutes were up, I escorted Ms. Esposito into the BAT room. Once there, I requested Ms. Esposito to submit to a lawful test of her breath for the purpose of determining its alcohol content. Ms. Esposito agreed to submit at 7:57PM. At 8:07PM, Ms. Esposito provided her first breathe sample of .048. At 8:11PM, Ms. Esposito provided a breathe sample of .055.

After providing the breath sample, Ms. Esposito was asked to provide a urine sample to for the purpose of detecting the presence of chemical or controlled substances. Ms. Esposito agreed to submit. I then Ms. Esposito advised of her Miranda warnings. After advising Ms. Esposito of her Miranda warnings, Ms. Esposito advised me she would continue further questioning. After a several questions, Ms. Esposito then refused with further questioning.

I then attempted to obtain a urine sample from Ms. Esposito. Ms. Esposito failed to provide a sample after several attempts. I then transported Ms. Esposito to booking into the Palm Beach County Jail. Shortly after, Ms. Esposito was booked into the Palm Beach County jail on 316.193.1 Florida Statue Misdemeanor DUI. All events occurred in Palm Beach County.

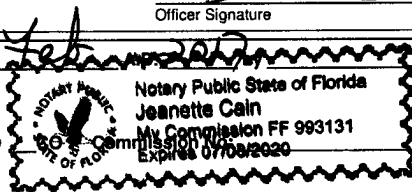

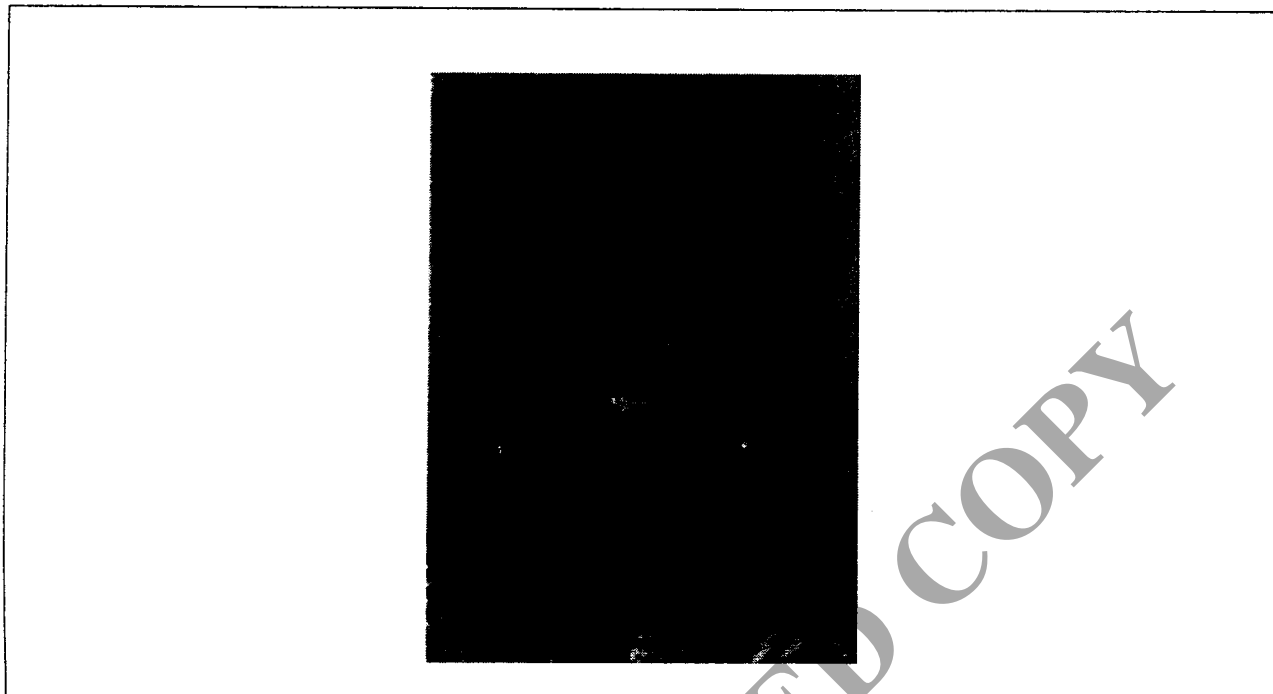
