


<p>On December, 9 , 2016 at approximately 2:13 a.m. I was dispatched to Dirty Martini (11701 Lake Victoria Gardens) Palm Beach Gardens, Palm Beach County, Florida in reference to a disturbance.</p> <p>While I was enroute, I was informed via dispatch that a white male was being restrained outside of the club because he was spitting on employees of the bar.</p> <p>Upon arrival, I made contact with a white male later identified through Florida Driver License as Shawn La Bonte. Shawn was detained and read his Miranda rights from a pre-printed card but refused to speak with me or answer any questions.</p> <p>I then went and made contact with the manager of Dirty Martini, John Buckley. John advised that Shawn was in the bar having drinks. The bartender cut off Shawn and Shawn became irate and began to cause a disturbance by yelling and demanding drinks. At that point in time, John made the decision to ask Shawn to leave. Shawn refused and said he would not leave unless they take him out. Shawn was grabbed by bouncers of Dirty Martini who began to escort him out. Shawn was uncontrollable while being taken outside therefore John assisted the bouncers. While escorting Shawn out, Shawn fell back onto John causing an ankle injury due to Shaws inability to be controlled. Once outside, Shawn continued to remain uncontrollable so he was restrained by bouncers until our arrival on scene.</p> <p>Palm Beach Gardens Fire rescue responded to the scene to treat John's ankle, John declined being transported.</p> <p>John gave a sworn video statement of the above listed events on my department issue body worn camera. Dirty Martini does have cameras that captured the above-mentioned events and will be placed into evidence once they are retrieved.</p>
