Driving Pattern Actual physical control (physical evidence putting the driver behind the wheel)

A red Lexus, FL DGHQ1, was stopped in the eastbound lanes of Okeechobee Blvd just east of Parker Ave facing west. The vehicle was in the left lane for eastbound traffic. The driver was the sole occupant of the vehicle and in the drivers seat. The vehicle was running and in drive with the headlights on. The driver was passed out at the wheel. WPBFR arrived and placed the vehicle into park.

Observation of Driver

Witness Knight saw the vehicle stopped facing oncoming traffic. He pulled up next to the Lexus. He saw the w/f driver passed out and sleeping. Ofc Streigold arrived along with WPBPD medics. Ofc Streigold noticed the driver was now awake. He noticed the driver had glassy eyes and slurred speech along with an odor of unknown alcoholic beverages on her breath. Ofc Streigold noticed the driver swaying when she stood up. I then met with the driver who was still sitting in the drivers seat. The driver had bloodshot glassy eyes. When asked to get out of the vehicle, she swayed while walking. I noticed that she had vomit on the front of her shirt. When speaking, I noticed she had slurred speech and a strong odor of unknown alcoholic beverages on her breath. The driver did not realize she had been driving on the wrong side of the road.

Drivers Statements:

The driver stated she was at E.R. Bradleys and on her way home. She did not know how much alcohol she had to drink then said 2 drinks. She said she drank vodka. The driver asked if she could pull over and have someone come pick her up. The driver said the monitor in the outside of her boot was to measure how much she had been drinking.

Odors:

Strong odor of unknown alcoholic beverages on her breath.

Upon starting this task, I showed her how I wanted her to follow the light. When asked to touch the tip of the pen light with the tip of her finger, she touched the tip of her nose and then touched the penlight. I observed the driver swaying during the exercise.

Walk and Turn Task

I instructed the driver to stand with her left foot on the line and put her right foot in front of it with her right heel touching her left toe. The driver was instructed to keep his hands down by his sides and was told to remain in that position until told to begin. The driver began to walk down the line and had to be brought back for the instructions. During the instructions, the driver could not keep her balance and stepped off the line. 2 more times she began to walk down the line before the instructions were given. I explained and demonstrated the exercise and she said she understood the instructions. On the first 9 steps, the driver did not touch heel to toe on any step and walked in a normal gait with a 4-6 inch space between heel to toe. She took 9 steps and stopped. She just turned around and did not turn as instructed. On the second 9 steps, the driver did not touch heel to toe on any step and walked in a normal gait with a 4-6 inch space between heel to toe. The driver raised her arms more than 6 inches for balance and did not count her steps out loud.

One Leg Stand

I had the driver stand with her feet together and hands down at her sides. I explained and demonstrated the exercise and she stated she understood the instructions. When told to begin, the driver lifted her right foot off the ground. The foot was approximately 1-2 inches off the ground. The driver put her foot down and when told to keep going, she then raised her left foot. She put that foot down 2 times. She counted to 1009 then said 10 thousand. When she continued, she said 10 thousand 2, 10 thousand 3, 10 thousand 4 twice. The driver swayed.

Finger To Nose

I had the driver stand with her feet together, hands down at her sides and index fingers pointed out. I explained and demonstrated the exercise and she stated she understood the instructions. I asked the driver to tilt her head back and close her eyes. On the first left, the driver touched under her nose then the tip with the pad of her finger. On the first right, the driver touched the tip of the nose with the pad of her finger. On the next left, the driver touched under the nose then the tip with the pad of her finger. On the next right, the driver touched the tip of the nose with the pad of her finger. On the next left, she touched under her nose with the tip of her finger. I observed the driver swaying. She did not keep her eyes closed.
