On March 4th, 2018 at approximately 1852 hours, I was dispatched to 10316 Forest Hill Blvd., Wellington, FL 33414 in reference to a shoplifting suspect in custody at the Macy's.

Upon my arrival, I met with Dwaine White, a loss prevention representative, who advised me that at approximately 1840 hours saw an unidentified subject in the kids department of Macy's. White advised that he observed the male, later identified as Sheikh Ahmed, take several items and place them in a Macy's bag that he brought into the store. White informed me that he observed the Ahmed attempt to leave the store passing all points of sale without any attempts to pay for the items. White was able to stop Ahmed outside of the store without incident and escorted him to the loss prevention office until my arrival. White advised me that the total amount of items came out to \$410.28 and provided me with an itemized receipt.

I then spoke with Ahmed, who advised me that he was only trying to call his wife because he did not have enough money for the items and needed her to bring a different method of payment. It should be noted that Ahmed was holding a cellphone to his ear during his exit. It should be further noted that Ahmed had never attempted to pay with the card before "calling his wife".

I then watched the video and observed Ahmed picking several items from the kid's department and placing them inside a Macy's bag. It should be noted that it appeared that Ahmed was looking out for employees while placing them in the bag.

I find probable cause to charge Ahmed with Retail Theft over \$300.00 pursuant to F.S.S. 812.015(8A)
