Loss prevention stated that she began to follow the subject throughout the Dept. store and observed the subject with a blue hand bag on her shoulder. The defendant was seen taking merchandise from its display case and concealed it in the purse she had in hand. The defendant was seen walking past several cash registers and did not make any attempt to pay for the concealed merchandise. The subject then exited the store without any attempt to pay for the merchandise. Loss prevention made contact with the defendant and identified herself and recovered the stolen merchandise. The following items were inside of the defendant's purse: Under eye concealer \$21.00, eyebrow pencil \$21.00, makeup setting spray \$32.00, Lip gloss \$16.00, liquid lipstick x2 \$44.00, mascara x2 \$47.00, eyelashes with glue \$23.00, eye shadow \$42.00, Blush x2 \$62.00, facial foundation \$35.00. The total value of the stolen merchandise is \$343.00.</p> <p>Contact was made with the Defendant who was identified Florida identification card as Shelby Julie Kendall DOB 07-06-99. The defendant was read Miranda from a pre-printed card which she understood and signed. The defendant confessed and stated that she stole the listed items from Sephora. Based on my investigation and the statements given the defendant was arrested and transported to the Palm Beach Gardens Police station for Retail grand theft per F.S.S 812.014 and later transported to Palm Beach County jail.
