 On the 12 day of February, 2017 at 15:24 (Specifically include facts constituting cause for arrest.)

I responded to 501 East Camino Real, The Boca Raton Hotel and Club Golf Course, in reference to a battery. Upon arrival I made contact with Detective Payne, who was working a detail at the golf event. Det. Payne advised me two W/M's were involved in the battery, and there were two independent witnesses that saw the battery take place. I spoke with W/M Sidney Vallon, who stated he was at the golf and car show event with his wife and children. Sidney stated he and Gary have a bad history with each other and they do not get along. Sidney stated he saw Gary and walked over to him and began yelling at him saying "do you want to call my wife a nigger to my face?" Sidney stated his wife is black and Gary had made past comments calling her a "nigger bitch" and other horrible names, so when he saw him, he confronted him. Sidney stated Gary pushed him, so he hit him back, which caused Gary a bloody nose. Ofc. Krigger spoke with W/M Gary Labate, who was being treated for his injuries. Gary stated he was at the golf/car event speaking to a man when someone appeared in his face and head butted him. Gary stated at this point he did not even know it was Sidney, until he regained his footing and realized it was Sidney who hit him. Gary stated he was knocked back by the headbutt, and when he got his balance again Sidney punched him. Gary stated he was hit by Sidney a total of two times which caused his nose to bleed. Ofc. Krigger took a video recorded statement of Gary Labate and the incident that occurred. Two independent persons witnessed the incident. H/F Hilda Rincon had her son Raul Gallor translate for her to Det. Payne before she left the event. Hilda advised she witnessed a younger white male (Vallon) who she pointed out to Det. Payne, screaming and hit an older white male (Labate) causing his nose to bleed. (see Det. Payne's supplement for further) A security officer working the event, H/M Michael Romero, wrote in his statement that he saw a younger man (who he identified to Ofc. Finne as Vallon) hit an older man (Labate) in the face causing injury. Romero wrote that he got in the middle of both men to stop the fighting. Romero heard Vallon yell at Labate about calling his wife black.
