Road. I was parked and stationary in the center median of Interstate 95 south of Indiantown Road monitoring southbound traffic. I observed a silver passenger car in the far left travel lane or the HOV lane moving at a high rate of speed. I visually estimated the speed to be 105mph in a posted 70mph speed limit zone and observed the vehicle passing other vehicles rapidly. Using my department issued laser I clocked the silver passenger car at 107mph in a posted 70mph speed limit zone at a distance of 923.1ft. I accelerated to overtake the vehicle and observed that the silver passenger car was a silver Nissan 4 door vehicle with an attached Florida tag of JXPU25. I moved to the left side of the vehicle and observed a younger light/medium skinned white or Hispanic appearing male with glasses driving the vehicle. I got behind the vehicle and activated my emergency lights and sirens to initiate a traffic stop on the vehicle. The vehicle pulled to the right shoulder of the Interstate 95 southbound exit ramp to Donald Ross Road. I observed that the driver of the vehicle jumped out of the driver seat and moved to the left rear seat of the vehicle while a white female moved from the backseat to the driver seat. I approached the vehicle and removed the driver who had jumped to the backseat from the vehicle and detained him handcuffing him behind his back. This driver was later identified by his Florida ID card as Michael Antonio Valentin (Florida ID card: V453541992890). He did not have a valid drivers license in any state. After being patted down for weapons for officer safety considerations he was placed in the backseat of my marked patrol vehicle. I then walked back to the silver Nissan and removed the white female that had jumped into the drivers seat. She was later identified by DAVID and FCIC/NCIC as Sierra Kathleen Rogers (FL DL: R262791015420). I provided the Florida ID card information of the driver to the Lake Worth Regional Communications Center (LWRCC) or Dispatch and they informed me that Michael Antonio Valentin had a confirmed warrant out of Martin County and that they would extradite (see information below). Based upon the above information and the totality of the circumstances I determined that there was probable cause to believe that Michael Antonio Valentin committed the offense of obstructing a law enforcement officer without violence as outlined in Florida State Statute 843.02 by jumping out of the driver seat and moving to the backseat during the course of the traffic stop. There is also probable cause to believe that Mr. Valentin drove a motor vehicle without a valid drivers license, never issued contrary to Florida State Statute 322.03. He was placed under arrest for the above offenses in addition to the confirmed warrant out of Martin County, FL. There is also probable cause to believe that Sierra Kathleen Rogers did also commit the offense of obstructing a law enforcement officer without violence as outlined in Florida State Statute 843.02 by jumping from the rear seat into the driver seat during the traffic stop. She was placed under arrest for the above offense. I transported Michael Antonio Valentin to the Palm Beach County Jail while Trooper P. Mcwherter (#1490) transported Sierra Kathleen Rogers to the Palm Beach County Jail. Mr. Valentin was issued a notice to appear for the excessive speed and driving without a drivers license, never issued. They were both subsequently booked without incident. All of the above events occurred in Palm Beach County, FL.
