On the above date and time officers were on routine patrol when we observed a Green in color Mitz bearing FL tag Y61SEB parked facing North in the parking lot of 1799 North Congress Ave (McDonalds). It should be noted the vehicle was on and there was a driver in the front seat of the vehicle that appeared to be sleeping.

Upon making contact with the driver, Officer Acosta and myself knocked on the window multiple times, however the driver did not respond. Officers were able to open the door of the vehicle and check on the driver and sole occupant of the vehicle later to be known as W/F Sierra Pettit (D.O.B. 10-08-97) who was very groggy. It should be noted in plain view I observed an open Blue in color Bud Light can sitting in the center console. Officers also smelled an odor emanating from the vehicle which based on my training and experience is known to be that of burnt marijuana.

Pettit was asked to step outside of the vehicle at which time she complied. While searching the vehicle I did find a green leaf substance that was located in a clear plastic baggy in a center console cup holder. Based on my training and experience I know this substance to be marijuana. Pettit was told to turn around and place her hands behind her back. As Pettit was turning around I was able to cuff her left wrist at which time she broke officers grip and attempted to strike me in the chest. Pettit then began to kick officers in the legs. Officers had to subdue Pettit and pin her up against the front of a patrol vehicle to gain compliance. Pettit was told by officers multiple times "stop resisting" however she continued to fight with officers. Officers were able to turn her around at which time she pulled away again and was placed against another patrol vehicle. Officers were able to handcuff Pettit, however Pettit kept kicking officers in their legs, in so officers subdued her by placing our legs up against hers to make her stop. Pettit was then taken to a patrol vehicle, however she refused to get inside. Officers called for assistance at which time officers were able to place Pettit into the patrol vehicle.

Once in the patrol vehicle Pettit started kicking the windows, and refused to stop at which time she was hobbled for her safety. It should be noted during this time I did use pressure points on Pettit's legs as she was kicking officers again. Pettit was then taken to Bethesda Hospital of medical clearance. While at the hospital Pettit bit Officer Acosta.

The marijuana was tested using a Deniquois-Levine Reagent test kit which indicated positive results for the presence of THC. The Marijuana had a gross weight of 3.5 grams and a total package weight of 11.8 grams.

Based on the aforementioned I find probable cause to charge Pettit with one count of Battery on a LEO pursuant to F.S.S. and one count of Possession of Marijuana less than 20 grams pursuant to F.S.S. 893.13(6)(B). Pettit was later TOT to PBCJ.


