On the 21 day of May 2018 at 18:22 (Specifically include facts constituting cause for arrest)

On Monday, May 21st, 2018 at approximately 1748 hours, I was dispatched to the area of Lake Shore Dr. and Lake Bend Dr. (Shores), Jupiter in reference to a suspicious incident. Upon my arrival, I made contact with off-duty DEA agent Matt Davis. I identified myself as Officer Morgan with the Jupiter Police Department, and Davis stated that multiple witnesses observed a white female and white male in the bushes next to the lake, performing sexual intercourse. Davis stated the male fled the area upon my arrival and that the female was currently walking down the side walk, west from our location. Davis pointed directly at a white female, wearing blue shorts and a gray tee shirt, later identified as W/F Kimberly M. Murphy 11/17/89.

I caught up to the suspect, Murphy and asked her to stop. I yelled at her "Police, Stop!" but she refused to acknowledge me. I yelled several more time to "Police, Stop!" but Murphy ignored my commands and continued to walk away from me. I walked directly in front of Murphy and yelled at her to stop and to sit on the ground. At this point, Murphy became hysterical and began to scream at me. I yelled at her to sit down and directed her with my hands. Once Murphy sat down, I informed her that she was observed by witnesses in engaging in sexual intercourse with a male subject in the bushes. Murphy became more agitated and appeared to be under the influence of alcohol or drugs. I asked her for her information, but she was unable to maintain focus and continued to cry and scream at me. At this time, I place Murphy into handcuffs, which were double locked and checked for proper spacing, for my safety. Due to her not cooperating and acting aggressive, Murphy was placed into the back of my marked patrol vehicle (unit #1405).

During this time Ofc. Anderson #313 arrived on scene to assist. I asked her to gather witness statements, while I stood by with Murphy. Ofc. Anderson observed the other suspect involved in the lewd acts (W/M Silas Balfour 1/1/4/85), running from the area. I observed Ofc. Anderson chasing the subject through several back yards, before he was apprehended and placed into custody. Ofc. Anderson stated that Blafour refused to stop



and was placed under arrest to resisting without violence. See Ofc. Anderson's supplemental report, for more information pertaining to Balfour's apprehension and the recorded witness statements. Ofc. Owen, Sgt. Hennessy, and Ofc. Marinucci, also arrived on scene to assist.

Based on the above information, witnesses statements, and the supplemental report from Ofc. Anderson, I believe there is probable cause to charge Kimberly Murphy with F.S.S. 877.03 Disorderly Conduct and F.S.S. 843.02 Resist Officer without Violence. I also found probable cause to charge Silas Balfour with, F.S.S. 843.02 Resist Officer without Violence. Murphy and Balfour were transported to the Jupiter Police Department Holding Facility to complete the appropriate paperwork. Upon completion, Murphy and Balfour were transported to the Palm Beach County Jail for booking procedures.

The Axon Body Worn Camera (BWC) was utilized for the duration of this call. The above listed statement is a summary of the BWC video and not purported to be verbatim.
