PROBABLE CAUSE

On the above date and time I was in service in Palm Beach County, FL. I was traveling eastbound on Southern Blvd (State Road 80) west of Interstate 95 (State Road 9). The weather was clear and traffic was moderate. A BOLO (Be On The Look Out) was put out for a white in color Volkswagen traveling southbound on Interstate 95 (State Road 9) south of Belvedere Rd. Dispatch then advised that the complainant was still land line behind the vehicle and believed that the driver of the white in color Volkswagen was impaired. Approaching Lantana Rd. (County Rd. 812) I observed the complainant's emergency hazard lights flashing as he was instructed to do so that we would be able to locate him and the vehicle as we traveled southbound on Interstate 95 (State Road 9). I then advised dispatch that I have located the complainant and the white in color Volkswagen. I observed the white in color Volkswagen, bearing the Florida tag of 301KYC, straddling the travel lane while unable to maintain a single lane and almost traveling into the lane to the right of it avoiding a collision it almost caused. I then activated my emergency lights and sirens in an attempt to conduct a traffic stop on the white in color Volkswagen. The white in color Volkswagen traveling at approximately 60 mph was not stopping or attempting to slow down. The white in color maintained its speed as I was following behind attempting to conduct a traffic stop with my emergency lights and sirens still activated. Trooper L. Tavares #1555, with his vehicles emergency lights and sirens activated as well then passed the white in color Volkswagen and positioned his vehicle in front of it in an attempt to gain the driver of the white in color Volkswagen's attention. The driver of the white in color Volkswagen then applied the vehicles brakes and came to a complete stop in the roadway just north of the Lantana Rd. (County Rd. 812) exit ramp. I then exited the vehicle and approached the white in color Volkswagen on its driver side in which I then observed a white female in the driver seat who was later identified, through her Florida Drivers License to be Sofia Tarafa 06/16/1990. I observed Ms. Tarafa seemed to be in a confused state of mind. I also observed Ms. Tarafa's eyes to be glossy and red in color. I then had Ms. Tarafa remove the keys from the ignition and step out of the vehicle. I then assisted Ms. Tarafa off the roadway onto the left paved emergency shoulder to a safer location. Trooper G. Cleary #1667 and Trooper L. Tavares #1555 then assisted with traffic control as I removed the white in color Volkswagen off the roadway and onto the left paved emergency shoulder. After the roadway was clear and the scene was secured I then made my way back to Ms. Tarafa. When I came into contact with Ms. Tarafa again I then advised her the reasoning of the traffic stop. I explained to Ms. Tarafa of the calls that were received from the complainant, and what I observed when on the roadway. I then asked Ms. Tarafa if there was any reason as to why she did not pull over when I initiated the traffic stop and why she had stopped in the roadway. Ms. Tarafa then advised me that she was just focused on getting home. Ms. Tarafa was then asked where she was coming from and where she was heading too. Ms. Tarafa then advised me that she was heading home to the Gables and was not able to advise me of where she was coming from. I then observed a blue in color wristband on her right wrist that read Double D Ranch and Saloon. I then asked Ms. Tarafa if that was the country bar she was coming from. Ms. Tarafa advised me yes that she was with friends. Ms. Tarafa was then asked if she had anything to drink. Ms. Tarafa then advised me that she did not have anything to drink. I then advised Ms. Tarafa that the reason I was asking was because aside from what I observed I can also smell the odor commonly associated with the smell of an unknown alcoholic beverage emitting from her breath as she speaks to me. I then asked Ms. Tarafa again if she had anything to drink. Ms. Tarafa again denied that she did. Ms. Tarafa's speech was blurred and mumbled. Ms. Tarafa then asked me if there was any way I could help her get home without driving under the influence. I then advised Ms. Tarafa I could not do so. Ms. Tarafa was then requested to perform a series of roadside exercises in which she refused to perform. I then advised Ms. Tarafa that if she refused to perform the roadside exercises that I requested of her to perform that I would be placing her under arrest. Ms. Tarafa then advised me to arrest her and again refused to consent to perform the roadside exercises requested of her to perform. (See Video)

Based on the totality of circumstances, Ms. Tarafa was placed under arrest for DUI pursuant to Florida Statute 316.193.1 at 02:17 AM. Ms. Tarafa was then searched and placed in the back of my patrol vehicle where she was then transported to the Palm Beach County Jail in which she arrived at 03:02 AM. After the defendants 20 min observation she was given the opportunity to provide a breath sample in which she refused to provide at approximately 03:25 AM.

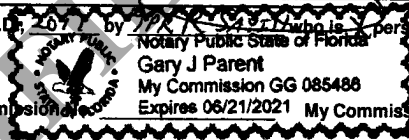
