It was the lone vehicle in the inside lane and I visually estimated the vehicle to be traveling 55 in a 35 MPH zone. I utilized the Falcon HR radar to acquire a reading of 54 MPH. I conducted a traffic stop on the vehicle at 1215 West Palmetto Park Road (Dunkin Donuts parking lot) and made contact with the driver/sole occupant of the vehicle, W/F Soledad Dominguez.</p> <p>Dominguez advised that she was traveling 30 MPH in a 35 MPH zone and that she was coming from Max's Grill which is a restaurant with a full bar in the city of Boca Raton. Dominguez advised that she had two drinks which she advised were two Blue Moon beers. I noticed that Dominguez's speech was slurred, her eyes were blood shot, and I smelled the odor of an alcoholic beverage emanating from her breath. When I asked Dominguez for her license, registration, and proof of insurance she had trouble locating those documents. It took several minutes for Dominguez to collect her license and registration. Dominguez advised that her proof of insurance was on her cell phone but she advised that she could not find where she had placed it and stated to me that she lost it. Dominguez also told me that I took her cell phone although I had not seen or touched her cell phone at this point in the investigation. It should be noted that the phone was later located on the driver's floorboard.</p> <p>I then asked Dominguez to step out of the vehicle and walk back towards my marked unit which she did. I then explained to Dominguez my observations and asked her if she would submit the standard field sobriety tasks to dispel my alarm that she was driving under the influence. Dominguez refused to answer the question of whether or not she would perform the tasks by remaining silent. I then advised Dominguez of her Taylor warnings. I explained that if she did not wish to submit to the standard field sobriety tasks, I would base my decision on the things that I had observed so far. Dominguez refused to</p>

answer the question of whether or not she would perform the tasks by remaining silent. While I was asking Dominguez if she would perform them or not she began crying and told me that she wanted to call her mother. Dominguez told me that she was not going to "fucking answer any of my questions".

Dominguez was placed under arrest for DUI pursuant to F.S.S. 316.193(1). I then transported her to BRPD for processing. Officer Bissoon responded to BRPD to operate the Intoxilyzer 8000. Dominguez refused to provide a breath sample, I read her implied consent, and she refused to provide a breath sample again. It should be noted that she remained silent and refused to answer the question of whether or not she would provide a breath sample, if she understood implied consent. I then read Dominguez her constitutional rights from a preprinted card which she continued to remain silent. Dominguez was issued a court date for DUI and transported to PBCJ. I requested Dominguez sign her DUI citation and rough arrest. After being warned that she would be charged with a refusal, she still refused to sign the citation by remaining silent and refusing to sign the citation. Dominguez was additionally charged with willfully refusing to sign a summons in violation of F.S.S. 318.14(3).
