D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Sgt. Piantoni ID# 270, of the Juno Beach PD, initiated a traffic stop on a Silver Mazda bearing FL tag 237PJV, at the intersection of Donald Ross Rd/US Highway 1, Juno Beach, because the vehicle was driving with no front right tire, and a shower of sparks were flying from the rim as it was driving East on Donald Ross Rd and turning North onto US Highway 1. I was also at the intersection of US Highway 1/Donald Ross Rd and I observed the violation as well. The vehicle came to a stop at 14051 US Highway 1, Juno Beach.

OBSERVATION OF DRIVER:

Upon looking at the driver, I noticed that she had bloodshot, watery eyes. When Sgt. Piantoni requested her license, registration, insurance, she initially ignored him and kept talking. When Sgt Piantoni asked again, she provided him with her credit card and her Florida driver's license, he then had to ask again for the registration and insurance, and she provided him with a handful of papers, in which her registration and insurance was included in.

After the conclusion of sobriety tasks, I arrested the driver. While attempting to bring her back to my vehicle she began pulling away from me and yelling profanities. When I opened the back door and tried to put her in the back of the car, she turned and faced me and tightened her muscles and refused to get into the vehicle after multiple orders from myself and Sgt Piantoni. I attempted to put her in the back of the car by lightly pushing down on her shoulders and she continued to tense up and actively resist me, at which time I pushed down on the pressure point on her right shoulder to gain compliance and put her in the back of the car. For that reason I have probable cause to charge the driver with resisting without violence in violation of F.S.S. 843.02.

DRIVER'S STATEMENTS:

While initially speaking with the driver, she admitted to Sgt. Piantoni that she had been drinking. I was also present at the time. She then stated that she had a couple of drinks, and then a few drinks while she was at J.J. Mugs (a bar in Jupiter, FL). She kept talking about her daughter (who was not present) and kept asking us to help her. While performing sobrieties she changed from being apologetic to aggressive and began yelling profanities at us.

ODORS:

Very strong odor of an unknown alcoholic beverage were being emitted from drivers breath and person as well as from the vehicles interior.

GENERAL OBSERVATIONS

SPEECH: Quick and broken some of the time (Nervous), slow and slurred other times, aggressive and profane.

ATTITUDE: Upset, apologetic, angry/annoyed, apologetic again, happy, angry again, crying

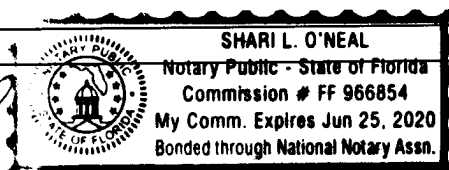
