confessed to _____ admitting to the below facts was found to have committed the below acts, resulting from my (described) investigation.

On the 22 day of May, 2018 at 18:48 (Specifically include facts constituting cause for arrest)

On May 22, 2018, at approximately 1900 hours, I was dispatched to 301 Worth Avenue in reference to an unknown female who stole a pair of Chanel sunglasses. The female was no longer on scene but was described as a W/F approximately fifty years of age, wearing a pink jacket, a black skirt, and high heels. As I spoke with the Director of Chanel, W/F Sally Chandler DOB: 10/27/1972, who stated a female, who was later identified via her California driver's license as W/F Sonja Gunilla Persson Linville DOB: 12/31/1958, stole the pair of Chanel sunglasses valued at \$545.00. I watched the security footage from earlier and observed Persson Linville enter the store at 1628 hours and began shopping. Persson Linville then went to the counter and was looking at small handbag and talking to the cashier, W/F Donna M. Troiano DOB: 03/06/1969.

Persson Linville picked up a pair of sunglasses from the counter and placed them on her face. She walked to the front of the store with the sunglasses on and then walked to the east side of the store away from Troiano. As Persson Linville returned to the cashier, she slid the sunglasses to the top/rear of her head in an attempt to conceal them from store personnel. Persson Linville purchased the small handbag, was given a receipt, and she continued past all points of sale out of the store at 1649 hours. Officer Waymire observed Persson Linville walking west in the 300 block of Worth Avenue matching the above description. Persson Linville walked passed Chanel again and did not attempt to reenter. Persson Linville was read her Miranda Warnings from a pre-printed card provided by The Palm Beach Police Department, which was audio recorded via patrol vehicle 806-microphone system. While talking with Persson Linville, I observed her reach into her purse, put the above sunglasses on her head, and continued to speak with Officer Waymire and myself as if the sunglasses belonged her. The sunglasses no longer had the sale tags attached. Persson Linville stated she was going to return the sunglasses "later".

Based on the above facts of this investigation, probable cause existed to arrest Sonja




