On the **13th** day of **January** 20 **18** at **20:50** A. M. P. M. (Specifically include facts constituting cause for arrest.)

UPON COMPLETING THE ROADSIDES, I ADVISED THE DEFENDANT THAT I CONCLUDED MY DUI INVESTIGATION AND, BASED ON THE OBSERVATIONAL CLUES ON THE SFST'S, THE CRASH, THE STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE EMANATING FROM HIS BREATH AND THE DEFENDANT'S ADMISSION OF CONSUMING ALCOHOL, DETERMINED THAT HE WAS TOO IMPAIRED TO OPERATE A MOTOR VEHICLE. I PLACED THE DEFENDANT UNDER ARREST FOR DUI. THE DEFENDANT VERBALLY STATED THAT HE UNDERSTOOD. I PLACED THE HIM IN HANDCUFFS THAT WERE CHECKED FOR PROPER FIT AND TIGHTNESS AND DOUBLE LOCKED AND PLACED THE DEFENDANT IN THE REAR OF MY PBSO MARKED PATROL VEHICLE. I TRANSPORTED THE DEFENDANT TO THE B.A.T. (BREATH ALCOHOL TESTING) FACILITY.

ONCE AT THE B.A.T. THE DEFENDANT WAS OBSERVED FOR A PERIOD OF TWENTY MINUTES, DURING WHICH TIME HE DID NOT INGEST ANYTHING, PLACE ANYTHING IN HIS MOUTH REGURGITATE OR VOMIT. AFTER THE TWENTY MINUTE OBSERVATION PERIOD THE DEFENDANT WAS PLACED ON CAMERA AND ASKED IF HE WOULD SUBMIT A BREATH SAMPLE FOR THE PURPOSE OF DETERMINING ITS ALCOHOL CONTENT AND HE REFUSED. I READ THE DEFENDANT FLORIDA IMPLIED CONSENT AND HE WOULD NOT VERBALLY GIVE A RESPONSE THAT HE UNDERSTOOD IMPLIED CONSENT. HE THEN STATED THAT HE "WAS GOING TO BE SICK", KNELT DOWN ON THE FLOOR AND BEGAN VOMITING INTO A TRASH CAN THAT WAS PLACED IN FRONT OF HIM. HE BECAME INCREASINGLY AGITATED AND REFUSED TO GIVE ME A RESPONSE ON WHETHER OR NOT HE UNDERSTOOD IMPLIED CONSENT. BEING THAT HE WOULD NOT RESPOND AFTER MULTIPLE TIMES OF ME ASKING, AND HE WAS VISIBLY NOT FEELING WELL, I NOTED IT AS A REFUSAL. THE REFUSAL WAS NOTED AND DOCUMENTED AT 23:13 HOURS. I DID NOT READ THE DEFENDANT HIS CONSTITUTIONAL WARNINGS ON CAMERA, ALTHOUGH THEY WERE READ TO HIM ON SCENE. I DID NOT COMPLETE THE Q&A PORTION SINCE THE DEFENDANT WAS NOT COOPERATING WITH ANSWERING QUESTIONS.

BASED ON THE ABOVE SET OF FACTS AND CIRCUMSTANCES, PROBABLE CAUSE EXISTS TO FIND SONNY JUNIOR ROSADO DID DRIVE OR BE IN ACTUAL PHYSICAL CONTROL OF A VEHICLE WHILE UNDER THE INFLUENCE OF ALCOHOLIC BEVERAGES, OR CHEMICAL SUBSTANCES AS SET FORTH IN FLORIDA STATUTE 877.111, OR ANY SUBSTANCE CONTROLLED UNDER CHAPTER 893 OR ANY COMBINATION THEREOF, TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED, OR WHILE HAVING A BLOOD ALCOHOL LEVEL OF .08 OR MORE GRAMS OF ALCOHOL PER 100 MILLILITERS OF BLOOD OR BREATH ALCOHOL LEVEL OF .08 OR MORE GRAMS OF ALCOHOL PER 210 LITERS OF BREATH, AND, DURING THE COURSE OF OPERATING A VEHICLE, AND BY REASON OF SUCH OPERATION, DID CAUSE OR CONTRIBUTE TO CAUSING DAMAGE TO THE PERSON OR PROPERTY OF SUZETTE ANNETTE HUGGINS, CONTRARY TO FLORIDA STATUTE 316.193(3)(a),(b) AND (c)(1). (1 DEG MISD)

I ISSUED THE DEFENDANT DUI CITATION A2FUDBP. I THEN TRANSPORTED HIM TO THE MAIN DETENTION CENTER, WITHOUT INCIDENT, FOR BOOKING AND PROCESSING.

D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 01/13/2018, at approximately 21:35 hours, I responded to the intersection of Lake Worth Road and Boutwell Road in Lake Worth, located in Palm Beach County, Florida to assist with a vehicle crash. Once on scene I made contact with CSA (Community Service Aide) Roberto Huambachano #14286 and D/S Brian Pherson who were already on scene. CSA Huambachano advised that he observed the driver of a green Honda Civic, bearing Florida tag 457NXN, later identified as SONNY JUNIOR ROSADO (defendant) DOB: 07/27/1987 by his Florida driver license, to have articulable signs of impairment. I assisted with the crash investigation and independently evaluated the crash scene, damages to vehicles. I made contact with the driver of both vehicles. Through the crash investigation it was discovered that the defendant was driving a green Honda Civic eastbound on Lake Worth Road and failed to stop at a solid red traffic signal light at the intersection of Boutwell Road and struck a blue four door Toyota Corolla that was traveling south on Boutwell, at the intersection of Lake Worth Road, and had the right of way with a solid green traffic signal. Prior to my arrival D/S Pherson obtained statements from independent witnesses on scene that saw the crash and came to the assistance of both drivers after the crash occurred. CSA Huambachano completed the crash report under PBSO case# 18-026237.

OBSERVATION OF DRIVER:

While on scene, and assisting with the crash investigation, I made contact with the defendant and observed that his eyes were very red, bloodshot and glassy. He appeared very distracted and was taking photographs of his car with his cellular phone and kept trying to show me the pictures instead of answering my questions. At times his responses to my questions did not have anything to do with what I asked him. He would get off subject. When he spoke his speech was slow and slurred and I could smell a strong and obvious odor of an unknown alcoholic beverage emanating from his breath that became stronger as he continued to speak with me. He swayed while standing in a resting position and walked with an abnormal gait. Upon completing the crash investigation, I advised the defendant that the crash investigation was concluded and I was initiating a separate DUI investigation due to the multiple signs of impairment I observed and he stated he understood. I read the defendant his Constitutional warnings from a PBSO issued Miranda card and he stated he understood. The defendant's mood changed and he started raising his voice, behaving defensive and giving more aggressive responses. I advised him multiple times that he was not obligated to answer my questions and that the investigation was to dispel my suspicion and rule out that if he was impaired.

DRIVER'S STATEMENTS:

He stated he understood and continued to answer questions. Post Miranda the defendant stated that he was the registered owner and driver of the vehicle. When I asked if he had anything to drink he stated that he had "several Black Heart shots from the liquor store". When I asked him what "several" meant he stated "Like 5". He then advised that he bought the single serve size shots of Black Heart rum and consumed them at the liquor store approximately "an hour ago". I asked the defendant if he would submit to voluntary SFST's and he consented. SEE Probable Cause PAGE 2 for further.....

ODORS:

Strong and obvious odor of an unknown alcoholic beverage emanating from defendant's breath that became stronger as the defendant spoke to me

GENERAL OBSERVATIONS

SPEECH: Slow, slurred,

ATTITUDE: Guarded, Aggressive, Combative, Mood swings, Emotional

CLOTHING: Black hooded, sleeveless shirt, Gray undershirt, Black basketball shorts, Black tennis shoes

MEDICAL/OTHER: Defendant initially denied having any medical conditions, injuries or physical impairments, being on any or taking any medications. Then he asked "what if I



Other Observations:

Bloodshot, red, glassy eyes. Unable to keep his head still, both eyes open and focused on following the stimulus to continue task. I had to instruct him multiple times to maintain his head still and both eyes open. Would only keep eye closest to stimulus open.

WALK & TURN:

Instructed and demonstrated. Defendant verbally stated he understood the instructions. Had to be repositioned while explaining task. The following clues were observed:

- Could not keep balance while listening to instructions
- Used arms for balance
- Completed improper turn
- Incorrect number of steps (Counted instructional stance as step #1)
- Missed heel to toe (Took large, spaced out steps)

ONE LEG STAND:

Instructed and demonstrated. Defendant verbally stated he understood the instructions. The following clues were observed:

- Swayed while balancing
- Used arms to balance
- Put foot down (On count 1008 and 1013)
- Counted "one thousand ten" twice
- Gripped his right hand on his pants to assist with balance
- Shifted body weight to the left to assist with balance

FINGER TO NOSE:

Instructed and demonstrated. Defendant verbally stated he understood the instructions. The defendant demonstrated proficiency with identifying his left from his right hand. The following clues were observed: Initially he asked "What do you want me to do? Touch which hand to where?" and did not respond to my commands. I had to instruct and demonstrate again.

- Swayed in a circular while completing task
- L- Multiple touches (nostril, top of nose) R- Top of nose L- Hovered, Paused, Top of nose R- Nostril, then top of nose R- Nostril L-Septum, top of nose.

ROMBERG ALPHABET:

Instructed and demonstrated. Defendant verbally stated he understood the instructions. He swayed in a circular motion while completing task. He recited the alphabet without difficulty until he got to the letter "S", then he took a long pause and recited " Z, T, U, V, W, X (took long pause again), Z. He skipped the letter "Y".




