DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Sgt. Bujnowski #214 was traveling west on SR 706 east of Pennock. Sgt Bujowski stated the vehicle passed him at a speed he believed to be approximately 55 mph. Sgt Bujnowski paced the vehicle bearing FL Tag HNSM13 at 55 MPH. The vehicle was also following too closely and came to a stop in the roadway. Sgt Bujnowski also stated the vehicle almost crashed into another vehicle. Sgt Bujnowski conducted a traffic stop on the vehicle for the above violations. See Sgt. Bujnowski's Supplemental PC for further.

OBSERVATION OF DRIVER:

I made contact with W/M Spencer W. Waldron (5/10/98) as Sgt Bujnowski was asking him to step out of the vehicle. Waldron appeared unsteady on his feet and was swaying while standing still. I asked Waldron to walk over to the parking lot area just to the west of where he came to a stop at. My vehicle was located in the parking lot of Ibis Bank at N Delaware and W Indiantown Rd. Waldron was not following my instructions and I repeated instructions several times for Waldron to stand with his feet together and arms down at his side. I also instructed Waldron several times I needed him to verbalize his responses to ensure I was able to tell if he understood instructions.

DRIVER'S STATEMENTS:

Waldron stated that he was heading home from his friend TJ's house east of the SR 706 bridge. Waldron stated he had not consumed any alcohol but did take Adderal around 0830hrs and zolpidem (Ambien) between 10-20 minutes prior to the traffic stop. Waldron stated he had no medical issues or injuries. Waldron agreed to conduct Standardized Field Sobriety Tasks.



Waldron was instructed the starting position several times and continued to move out of the starting position. Waldron stated he understood the instructions. Waldron took approximately 16 steps out missing heel to toe several times, stepping off line several times, and utilizing his arms for balance. Waldron failed to turn around as instructed and did not take the 9 steps back down the line.

ONE LEG STAND:

Waldron stated he understood the instructions. Waldron failed to keep both legs straight and his elevated leg had a very noticeable bend. Waldron's elevated foot was also not pointed straight out as instructed. Waldron used his arms for balance and was swaying while keeping his foot elevated. Waldron began to hop to maintain his balance and put his foot down. Waldron asked if he should lift his other leg and lifted his other leg after being told it was his choice.

FINGER TO NOSE:

Waldron stated he understood the instructions. Waldron touched above his nose on the first left, to the right side of his nose on the first right, on his nose on the next left and two rights, and then touched to the left side of his face on the final left.

ROMBERG ALPHABET:

Waldron stated he was working on college at FAU and knew the alphabet. Waldron recited the alphabet incorrectly.




