He informed me that he was not sure if he could perform the English alphabet at first, but then later stated he felt he wanted to try. While attempting the alphabet, Baluik would continue to open his eyes even after being instructed to keep them closed. Baluik missed a few letters in the beginning of the alphabet, and then got confused half way through. Baluik stopped and then picked up towards the end of the alphabet. Baluik finished the alphabet with an incoherent letter, and continued after the letter Z.

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time, I was dispatched to the intersection of Caloosa Blvd. and Beeline Hwy. in unincorporated Palm Beach County in reference to a vehicle crash. Upon my arrival I met with Palm Beach County Fire Rescue on scene, and observed the driver of one of the vehicle's still sitting behind the wheel of a White Toyota with Florida License plate Z92ALB, still in actual physical control of the vehicle. The driver was later identified by his Florida Driver's License as Stanley Baluik, W/M 10/5/1935. I observed Baluik behind the wheel of his vehicle, holding the keys to the vehicle. The crash was documented under PBSO case number 17144711. The vehicle was facing to the North East at it's final stop. Upon completion of my crash investigation, I found that Baluik failed to yield to the other vehicle. The other vehicle was traveling North West on Beeline Hwy. and was traveling as the right of way vehicle. Baluik's drove across Beeline Hwy. to the West, from Caloosa Blvd., and crossed in front of the other vehicle, contributing to the crash.

## OBSERVATION OF DRIVER:

I spoke with Baluik at his vehicle, and asked if he was alright. Baluik made incoherent sounds and mumbled, unable to answer. I asked Baluik if he needed help from Fire Rescue to which he stated that he did not, and that he was not injured. I asked Baluik how the crash happened, and he informed me that he could not remember, then later gave multiple different explanations as to how it occurred. Baluik's speech was slurred, thick, low, and at times difficult to understand. His eyes were red and glossy, his gross motor skills were slow and lethargic, he had an uneven gate, and I could smell the odor of an unidentified alcoholic beverage emitting from his breath, which intensified as he spoke to me. While speaking with Baluik, I observed that he was drooling from his mouth. It should also be noted that I observed what appeared to be fecal matter on the driver seat of Baluik's vehicle.

## DRIVER'S STATEMENTS:

While speaking with Baluik during my crash investigation, he informed me that he was not sure where he was, and could not explain to me where he was going. I asked him multiple times if he was alright, because he was not making sense, to which he responded that he was alright and did not need to be assessed by fire rescue. Baluik then explained that he was having trouble speaking and explaining where he was coming from because he had been drinking wine. Upon completion of my crash investigation, I informed Baluik on camera, that I was no longer conducting a crash investigation, and would now be conducting a criminal D.U.I investigation. I then read Baluik his Miranda rights, and he advised me that he understood them. I asked Baluik what happened in the crash, to which he informed me that he was the only person in his vehicle, and was the driver of his vehicle.

## ODORS:

I asked Baluik what he had done earlier that day to which he stated that he went to dinner at Outback, and then went to the race track, where he stated he had three to four glasses of wine.

## GENERAL OBSERVATIONS

SPEECH: SLOW, THICK, SLURRED, LOW, AND AT TIMES DIFFICULT TO UNDERSTAND

ATTITUDE: SWITCHING FROM COMPLIANT AND CONFUSED, TO DEFIANT.



**ROADSIDE TASKS**

**HORIZONTAL GAZE NYSTAGMUS:**

- LT EYE-LACK OF SMOOTH PURSUIT
- RT EYE-LACK OF SMOOTH PURSUIT

**Other Observations:**

Baluik showed obvious signs of Horizontal Gaze Nystagmus. Both eyes showed a lack of smooth pursuit, distinct and sustained Nystagmus at Max Deviation, and onset of Nystagmus prior to 45 degrees. Before I had Baluik conduct HGN, I asked him to touch the tip of my light stimulus with his right pointer finger.

**WALK & TURN:**

Baluik tried to reach out and touch the light stimulus before being instructed to. Once he was instructed to reach out and touch the light stimulus, he missed the tip of the light with his finger on the first try. He then tried again, and missed the tip of his finger, and instead touched the tip of the pen with the bottom of his finger.

While conducting the walk and turn task, Baluik had trouble understanding the instructions. Baluik would not stand in the starting position as explained to him. While standing near the line used for the walk and turn, Baluik would attempt to start before being instructed, and could not stand on the line without stepping off. Baluik was explained the task multiple times, and I demonstrated the task multiple times for him, but he informed me that he was having trouble understanding the instructions. when asked which part of the instructions he was having trouble with, Baluik could not describe what he was not understanding. While explaining the task, Baluik would start before being told to do so. Baluik eventually stated that he understood the task, and wanted to try.

**ONE LEG STAND:**

While attempting the walk and turn task, Baluik was not able to perform it as instructed. Baluik would only take three to four steps, instead of the instructed nine, and when asked why he only took four steps, he informed me that he thought that's how many he was told to take. Baluik did not walk on the line, and did not bring one foot around to the front of the other. Baluik did not take any steps with heel to toe, and did not walk on the line. While explaining the one leg stand, Baluik informed me that he did not think he could perform the task, because he did not think he could balance on one foot. He informed me that he did not feel that he could perform this task, even if he had not been drinking. Baluik would attempt the task, but was not able to perform it as instructed. I asked Baluik if he wanted to move on to another task, and he requested to attempt a different one.

**FINGER TO NOSE:**

I instructed Baluik as to how to perform the finger to nose task, and instructed him to stay in the starting position until he was instructed to move. Baluik would copy my movements as I demonstrated them, and would tilt his head back, even after being reminded to stay in the starting position so he could observe my demonstrations. Upon completion of the instructions for the finger to nose task, Baluik informed me that he understood the instructions, and that he felt more comfortable with this task as compared to the last one. While attempting to perform the task, Baluik would continue to open his eyes, and at times, only one eye. He would also raise his head up, and would not tilt it back as instructed. The order I requested Baluik to perform the task in was as follows; LRLRRL. After the first attempt, Baluik left his finger on his nose, and did not lower his hand immediately back down to his side.

**ROMBERG ALPHABET:**

I instructed Baluik again to bring his hand back down to his side after he touches his nose. Baluik continued to delay his reaction after he attempted to touch his nose, and did not immediately bring his hand back down to his side. Baluik missed the tip of his nose on every attempt. Baluik would touch the side of his nose, and his cheek below his eye. On one attempt Baluik did not make contact with any part of his face. When I changed up the order of instructions, Baluik raised one hand, and then the other, and eventually raised the correct hand.


