NARRATIVE:

On 05/13/2018 at approximately 0040hrs I was westbound on Northlake Blvd from Beeline Rd. in my issued unmarked vehicle Asset# 52790 which is a calibrated vehicle and also has a full light and siren package installed.

Upon reaching N SR 7, I began observing a white Mazda bearing FL Tag Y52XCU which was also traveling westbound on Northlake Blvd. In the area of Northlake Blvd and Ibis Blvd. the white Mazda sped up suddenly and began to tailgate a vehicle which was traveling westbound in the #1 lane on Northlake Blvd. The white Mazda continued to travel approximately 15' from the vehicle in front of it for a period of approximately 100'. Finally, the vehicle in the #1 lane merged into the #2 lane to allow the white Mazda to pass. I was directly behind the white Mazda at this point and paced the white Mazda using my vehicle as it increased its speed to 90mph. (speed limit in this area is 55mph) It should be noted, the white Mazda appeared to be with another smaller white vehicle as both vehicles were traveling at the same speed, weaving in and out of lanes.


The white Mazda then sped up to over 100mph and my vehicle is not capable of going over that speed. The white Mazda then approached the intersection of Northlake Blvd. and Coconut Blvd. and slowed as the light turned red which allowed me to catch up to it. The white Mazda and the other small white vehicle ran the red light at the intersection of Northlake and Coconut Blvd and began to travel southbound on Coconut Blvd. in the #2 lane. The #2 lane merges into the #1 lane approximately 3/4 mile south of Northlake Blvd. There was a large truck in the #1 lane at the point in

which the lanes merge and the white Mazda cut the large truck off by interrupting its travel in the #1 lane. The large truck had to break hard to avoid hitting the white Mazda. The white Mazda then sped back up again to a speed of 70mph in a 45mph zone and the smaller car which was in front of the white Mazda went into oncoming traffic to get away from me as I activated my emergency lights and siren to conduct a traffic stop of the white Mazda.

The white Mazda did not pull over immediately, but rather continued for approximately another 3 blocks before deciding to pull over. After pulling over, I made contact with the driver who I identified by his FL DL as Stefan S Babulal. Due to his driving pattern, I asked him to step out of the vehicle and informed him he was under arrest for Reckless Driving. I subsequently informed Babulal of his other charges as well.

I had the white Mazda towed per rotation, and Babulal was transported to the PBC Jail by D15 deputies.
