On the **8** day of **December**, **2017** at **06:38** (Specifically include facts constituting cause for arrest.)

The following incident occurred in the City of Delray Beach, Palm Beach County, FL.

On 12/8/17 at approximately 0518 hours I responded to corner of W Linton Blvd/S Congress Ave in reference to a disturbance. Upon arrival I made contact with a Hispanic female, later identified as Stella Seda. When I made contact with Seda, I could smell a strong odor of an unknown alcoholic substance from her breath. Seda`s eyes were bloodshot and glassy. Seda stated she got picked up by an Uber driver in Boca Raton to bring her home in Davie. I informed Seda that she was in Delray Beach which is north of Boca Raton and that Davie is south. Seda corrected herself and stated that she got picked up at Atlantic and I95. Seda stated she cancelled the Uber ride and informed the driver to drop her off somewhere because she had contacted someone else to pick her up. As I was talking to Seda, she became upset and told me to "go get coffee and donuts" because I could not help her. Seda continued to be belligerent and unruly by stating that I was a "piece of shit cop and I think I`m above the law". Seda also stated that she works for the PBA and requested my badge number and name because she was on the phone with the PBA president who she stated was coming to the scene.

I told Seda to wait a minute as I made contact with Ofc. Smith via landline who was with the Uber driver, Antonio Joseph, at the gas station. As I was on the phone with Ofc. Smith, Seda approached me and demanded my name and badge number and took out her phone to take a picture of my name tag. Seda stuck the phone to my face as I told her to back off while I talk to Ofc. Smith. Ofc. Smith made contact with the Joseph at the gas station and he stated that he picked up Seda at 521 E Atlantic Ave. Joseph stated that Seda was being belligerent and unruly the minute she entered his vehicle. Joseph advised that while driving on Interstate 95 Seda cancelled the fare. When Joseph asked what Seda wanted to do Seda cursed at him and told him "I`m going to punch you. You`re an asshole. Fuck you." Joseph stated that he would contact Uber and have Seda flagged for future Uber service. Seda stated the argument between her and Joseph was verbal and at

no time did the argument become physical. Officers determined that there was no crime committed and it was a civil issue between the parties. Seda stated she had contacted PBA and was waiting on them to come to the scene. Seda started ignoring officers and when asked by Ofc. Smith if she "needed anything from us" she said, "no" leading us to believe she no longer needed our assistance.

As officers were leaving the scene, Seda grew upset and walked in the road in front of my marked police vehicle and prevented me from leaving the scene by sitting on the hood of my police vehicle. I gave Seda numerous commands to remove herself from the hood of my vehicle but she refused my commands. Seda was being belligerent and cursing at me while I was giving her commands to get off my vehicle. After refusing to remove from my police vehicle, Seda was taken into custody for disorderly intoxication.

Based on the above stated facts, probable cause exists to charge Stella Seda with Disorderly Intoxication pursuant to F.S.S 856.011.
