On the **23** day of **February**, **2018** at **02:53** (Specifically include facts constituting cause for arrest.)

On 02-23-2018 at approximately 0129 hours, I responded to 3601 N Military (Lynn University), in reference to a grand theft.

I made contact with Head of Campus Security Jessica SanMarco, who provided the following account: At 0107 hours she was informed that an unknown person(s) stole a golf cart from the plaza and crashed it into the student center door causing approximately \$1000 worth of damage to the door. The golf cart is valued at approximately \$7000. SanMarco advised they do want to prosecute. SanMarco stated the golf cart does not need keys to operate.

I reviewed the video footage and at 0016 hours, I observed a white female, with blonde hair, a white top, and a blue skirt enter the student center with a white female with brown hair, a brown shirt, and ripped jeans later identified by SanMarco as Stephanie Nardelli. At 0043 hours, both females leave the student center. At 0044 hours, the golf cart smashes into the front door of the student center. Nardelli who appeared to be sitting in the passenger seat, but appeared to be leaning over to steer the golf cart, exited the golf cart stumbling. In the video it looks like Nardelli was the driver of the golf cart. When Nardelli exited the golf cart she appeared to be stumbling and possibly injured.

I observed the golf cart and the damage to the front door. I was unable to process the golf cart, because it started raining heavily.

SanMarco stated at 0046 hours Nardelli entered the north side residence hall room 315. Officer DeArmas and I accompanied SanMarco to the residence hall. SanMarco tried knocking multiple times on the door of 315, but no one answered. SanMarco stated in her sworn written statement she was concerned for Nardelli's safety and entered the room on the basis of a welfare check. SanMarco entered Nardelli's room on her own accord, while

myself and Officer DeArmas waited by the door. SanMarco repeatedly tried to wake Nardelli, but she was not responding. After repeatedly trying to wake Nardelli up, and not being able to do so, I became increasingly more concerned for her safety. I asked SanMarco if Nardelli needed medical treatment. SanMarco responded I don't know. Myself and Officer DeArmas then entered the room. When I entered the room I immediately recognized Nardelli as the same brown haired female in the video. On the floor I observed the same ripped jeans she was wearing in the video. Nardelli finally became alert.

I read Nardelli her constitutional warnings, after being read her constitutional warnings Nardelli stated she does not want to speak to me.

Based upon my investigation, I placed Nardelli under arrest for Grand Theft pursuant to F.S.S. 812.014 (2c2)

While being transported to the Boca Raton Police Department for processing, Nardelli made a number of spontaneous utterances about her being on the golf cart. Nardelli at one point asked about the other girl on the golf cart, and stated she(Nardelli) wasn't driving it.

Once processed she was transported to Palm Beach County Jail.
