NARRATIVE:

On Wednesday November 29th, 2017 at 0844 hours defendant w/f, Stephanie Taylor Jarrett, DOB: 01/03/1998 was found to be in possession of four fictitious driver licenses based on the following facts:

Jarrett was traveling through the Palm Beach International Airport (PBI/A) en route on a flight to Philadelphia, PA. Jarrett entered the TSA security checkpoint on concourse C. Jarrett advised TSA security officials that she had lost her identification, and did not have a picture ID. TSA officials while attempting to identify Jarrett found four driver licenses with her picture on each license. The four licenses were discovered inside of a ladies wallet. License #1 reference D/L # 31 618 124 was a Pennsylvania driver license listing Jarrett's name and a date of birth of 01/03/1998 License #2 reference D/L # U021944735 was a Missouri driver license listing Jarrett's name and a date of birth of 01/03/1996 License #3 and 4 reference D/L # J0771 78083 51925 were duplicate New Jersey driver licenses listing Jarrett's name and a date of birth of 01/03/1992 Three of the driver licenses listed different addresses in their perspective state. At this time the Palm Beach Sheriff's Office was notified, and I responded along with PBSO Deputy Dan Wood #4632. Upon our arrival I was handed the driver licenses. I noted there were three different date of births for Jarrett. Deputy Wood made contact with Jarrett, and conducted a verbal interview with her. Prior to the interview Jarrett was read her constitutional rights from a preprinted Miranda Rights card. Jarrett stated her real name and date of birth saying the Pennsylvania driver license was real and valid. Jarrett stated to Deputy Wood the other three driver licenses were fake and not real. She told Deputy Wood an individual in Pennsylvania was the person who gave her the fake D/L's. Jarrett said informed Deputy Wood that she has never used the fake driver licenses, and had forgotten they were inside her wallet. Jarrett due to her knowingly having in her possession three fake driver licenses was placed under arrest. A search incident to arrest revealed a fourth fake driver license, which was a duplicate of the above listed Missouri driver license. This license was discovered inside Jarrett's wallet. Jarrett was charged with four counts of unauthorized possession of a fictitious driver license.
