Narrative:

On the above date and time, I responded to [REDACTED] in reference to an unwanted guest complaint. Information was received regarding a very intoxicated male, who was being violent, kicking a gate, property and throwing cans of beer on the complainants mother. The male was noted to be the boyfriend of the complainants mother. He was last seen wearing a light shirt and tan pants.

On arrival, Ofc. Shepaum and I made contact with the complainant and resident, Ariana Finno, who advised that her mother's [REDACTED] boyfriend, Stephanos Kambouris, had been drinking all day. Ariana advised that she heard [REDACTED] yelling that Kambouris had broke the residence gate. Ariana stated that she heard Kambouris yelling/screaming for her and [REDACTED] to take him home. Ariana advised that she agreed to take Kambouris home. Ariana, her 4 year-old daughter, [REDACTED] and Kambouris all proceeded to the parking, west of the residence. Ariana advised that Kambouris said to walk ahead and get out of the way. In the parking lot, Ariana observed an altercation and Kambouris dump a can of beer all over [REDACTED]. They did not give Kambouris a ride home and he left the area on foot.

I subsequently interviewed [REDACTED] who advised that she had just taken a shower after the incident. [REDACTED] advised that she and Kambouris have been in a relationship for almost 3 years, but never resided with each other. [REDACTED] indicated that their relationship is active, and both were reportedly intimate as of last night. [REDACTED] confirmed that Kambouris had been drinking heavily all day. [REDACTED] advised that her elderly mother, Jeanette Finno, wanted Kambouris to leave the residence, due to him being belligerent and making inappropriate comments. [REDACTED] stated that while walking out of the residence, she observed Kambouris slam her residences gate, breaking such. [REDACTED] advised that in the parking lot, Kambouris purposely dumped a can of Busch beer on her. [REDACTED] stated that she became soaked from the beer, and returned home. [REDACTED] had changed her clothing; however, showed me a maroon shirt which was wet and smelled of beer. [REDACTED] was not injured as a result of the incident, nor displayed any visible injury; medical attention was not requested. [REDACTED] directed me to a wet spot in the parking lot where Kambouris had dumped the beer on her.

I observed a broken piece of wood to the residence gate. I also observed a can of 16 oz. Busch beer in the grass several feet from where the incident occurred. [REDACTED] reported having past domestic troubles with Kambouris and cited his drinking as as result for his actions today. [REDACTED] was certain that Kambouris intentionally dumped the beer/liquid on her person. Ariana completed a sworn written statement as to her observations. [REDACTED] refused to complete a sworn written statement, advising she loves and cares about Kambouris. Ariana briefly left the area, but returned after spotting Kambouris near the entrance to her community. I left the residence and traveled south on Live Oak Lane. I observed a male subject in the grass, near the intersection of Live Oak Lane and Sandalwood Drive. The male subjects clothing matched the aforesaid description. I was able to confirm that the subject was Kambouris, who said that he was waiting for a ride home. Kambouris admitted that he poured beer on [REDACTED] because she cheated on him. Kambouris advised that he knew the gate was broken, but did not do it on purpose. Kambouris did appear to be intoxicated while speaking with him.

Kambouris was thus arrested and charged with simple battery (dating violence) pursuant to F.S.S. 784.03 (1)(a)(1). Kambouris was advised of his charge and advised that [REDACTED] started the incident by throwing water at him. I transported Kambouris to BBPD for processing. He was then transported to the PBCJ.


