On the 2 day of April, 2018 at 18:20 (Specifically include facts constituting cause for arrest.)

On 4/2/2018 at approximately 1740 hours, I responded to 431 W Camino Real, apartment 3, in reference to a welfare check on a white female Briana Perrotte after her mother received a call from her screaming on the phone.

Upon arrival at the previously stated address, I observed a blood trail leading from the parking lot, to the closed door of apartment 3. I also observed a shattered front window that appeared broken from the outside, as there was no glass on the ground outside. Officer Radford arrived on scene at this time as a back-up officer and we attempted to make contact. On the first attempt, a male acknowledged our presence by stating "who is it". I then replied, loudly and clearly, "Boca Raton Police". After identifying myself as a police officer, there was no further contact. Sergeant Patterson arrived on scene and used his vehicles public address system to issue commands to the interior of the now, unresponsive apartment.

After several direct commands, and approximately 15 minutes, a white male, later identified as Stephen Shannon, by his Florida driver license, opened the door and proceeded to follow the remainder of commands given. I asked if there was anyone remaining inside and Shannon said "my girl is in the shower".

Sgt. Patterson and I began checking the interior of the apartment and I observed the following: broken glass on the floor, blood pools on the floor throughout the bedroom, a blood stained towel lying next to the bed, and slight flooding emitting from the bathroom. The interior appeared as if a physical altercation took place recently. There were clothes scattered, the bed was moved, and there were multiple items moved/thrown from their original locations.

While moving through the apartment, I repeated loudly "Briana, Briana Police". Briana replied by stating she was in the shower. I located Perrotte, sitting on the shower



floor bleeding from her facial area. After Perrotte advised she was ok, I checked the remainder of the apartment interior and found no other subjects.

While speaking to Perrotte I observed lacerations to her upper and lower lips, bruising and swelling on her right eye, and bruising on her neck. Perrotte said she did not know how she sustained the injuries. I then spoke to Shannon. He advised nothing occurred today and he remembers Perrotte falling down stairs the previous day. I checked Shannon for injuries and observed bruising on his right hand and abrasions on his right hand small finger knuckle.

Perrotte later advised Officer Schuss that she had been dating Shannon for seven years and they currently live together at this location. She said she was sleeping on the bed and did recall what happened or how she got hurt. See Officer Schuss's report for further.

I placed Shannon under arrest and charged him pursuant to FSS 784.03(1) Domestic Battery. He was transported to the Boca Raton Police Department and later to the Palm Beach County Jail for further processing.
