## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 09/24/2019 I was stationary at Alt A1A/Burns Rd conducting traffic enforcement when I observed a silver Mercedes bearing FL Tag (Y64THW) travel North on Alt A1A at a high rate of speed. I visually estimated the vehicle to be traveling in excess of 80 mph in a 45mph zone. I attempted to catch up to the vehicle however it continued to travel at a high rate of speed north-bound toward Alt A1A/Hood Rd. At the intersection of Alt A1A/Hood Rd, I observed the vehicle make a left turn on a red arrow to travel West on Hood Rd. I then observed the vehicle accelerate toward the next intersection of Hood Rd/Frenchmans Crossing Entrance which had a solid red light for West-bound traffic. The vehicle continued through the intersection and failed to stop at the red signal. The vehicle then approached the intersection of Hood Rd/N Military Trail where it came to a complete stop at the red traffic signal. I maneuvered behind the vehicle and ignited my overhead light bar and activated my siren to initiate a traffic stop at the intersection. I exited my vehicle and approached the driver's door. Upon approach, I observed a white male sitting in the driver's seat who was the sole occupant of the vehicle. I identified the driver via his FL DL as Stephen Keith Rhoads.

## OBSERVATION OF DRIVER:

Upon approach to the vehicle I observed Stephen sitting in the driver's seat and looking forward. I shined my flashlight inside the vehicle at Stephen's face to gain his attention because he did not look at me as I stood outside of his door. I continued to shine my light at Stephen's face until he looked back at me. He then stared at me with a blank face for several seconds and then rolled down the window. As Stephen looked at me I observed his eyes to be dilated more than a normal person's, his eyes to be bloodshot and watery, and his face to be flushed. I identified myself as an Officer with the Palm Beach Gardens Police Department and requested Stephen's driver's license, vehicle registration, and proof of insurance at which he provided his driver's license and vehicle registration.

## DRIVER'S STATEMENTS:

I asked Stephen where he was going to and he stated "home." I asked where he was coming from and he stated "Swamp Grass Willy's." I then asked if he had anything to drink and he stated "a couple beers... 2 or 3." I also asked when he consumed the last beer and he stated "just now." I then asked if he normally drinks and he stated "no." I began talking to Stephen about his driving pattern. I asked him why he was driving so fast and he stated he recently had a home invasion and theft of money so he was angry due to it. He also stated he was upset. I then advised him of my observations and concern of him being intoxicated and requested he perform several field sobriety exercises. Stephen stated he understood and agreed to the exercises. As he stepped out of his vehicle he held onto the door as it was propped open to regain balance to stand upright.

## ODORS:

Strong odor of alcohol emitting from his breath from a conversational distance.

## GENERAL OBSERVATIONS

SPEECH: Low, slight slur

ATTITUDE: Polite, upset.

CLOTHING: Ruffled

MEDICAL/OTHER: Stephen stated he consumed Librium (10 mg) at approximately 10:00am and Clonazepam (0.5 mg) at approximately 12:00pm. He stated he was recently struck in the face by a gun during a home invasion. I observed a slight purple coloring to his left cheek bone. He also stated he had gastrointestinal issues, hypoglycemia, and general anxiety disorder.

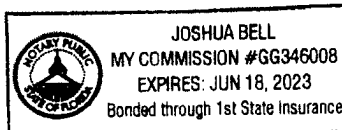

**Other Observations:**

Orbital Sway, Vertical Gaze Nystagmus in both eyes. Lack of convergence with left eye coming toward center and rebounding outward and the right eye staying straight.

**WALK & TURN:**

I began giving the instructions to Stephen when he stopped me and stated " I understand, you dont have to explain it to me." He then moved from the starting position. I advised him to back to the starting position and demonstrated as well as explained the instructions again. Stephen stated he understood the instructions. During the first set of 10 steps Stephen stepped off the line on steps 3, and 7. On steps 2, and 4 he paused before taking the next step. Stephen completed an improper turn by turning to the right and lifting both feet. During the second set of 10 steps, Stephen stepped off the line on steps 2, 7, 9, and 10. During the second steps he stated "You made me a little nervous." He then completed the exercise, turn around, placed his arms out in a "T" from his body and stated "I failed it." I asked how many steps he took and he stated "9." I asked if he knew how many I told him to take and he again stated "9." Stephen did not realize even after explanation that he took 10 steps both times.

**ONE LEG STAND:**

During the instruction stage I explained the instructions and demonstrated the exercise. Stephen asked to have the instructions repeated at which I repeated the instructions and demonstrated the exercise again. Upon completion of the instructions/demonstration, Stephen stated "Okay look, guys, I can tell you right now I am not going to be able to complete that exercise, because I've had too much to drink, let's go ahead and just get it done." I then stated "I'd like to do the exercises." Stephen then went back in the starting position, immediately lifted his right leg and began counting while looking at me. I told Stephen to go back in the starting position and then instructed him to begin the exercise. During the exercise he counted "one, one thousand one, one thousand two" and then placed his foot down. I then began to advise him to continue counting when he picked his foot back up before I could finish my statement and he began counting "One thousand one" and then placed his foot down on the ground and shrugged his shoulders. I asked if he was finished and he said "Yep, lets do it... DUI, done."

I advised Stephen of the next exercise and he stated "lets just get it done... I'm driving under the influence, I admitted to it." I then asked if Stephen was refusing the SFST's and that his refusal can be held against him. He then stated "What I'm doing is telling you that uh, I had too much to drink tonight, and I'm admitting it to you."

Left- Pad of the left finger touched his left eye, then corrected to the bridge of his nose.

Right- Pad of the right finger touched the bridge of his nose

Left- Pad of the left finger touched the left near/left cheek

Right- Pad of the right finger touched the bridge of his nose

Right - Pad of the right finger touched the top of the nose

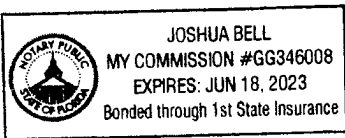
