

Upon arrival, I observed the front door to apartment # 10 wide open and the lights were on. I knocked on the door and announced myself as Officer Newman of the North Palm Beach Police Department. I did this multiple times before I was met by a W/M, later identified as Stephen L. Brandt 4/2/1977. Brandt was wearing a green t-shirt, black basketball shorts and no shoes. I asked him to step outside and talk with me. I smelled a strong odor of an unknown alcoholic beverage emanating from his person when he spoke. Brandt advised he had a verbal argument with his girlfriend of 5 years, Laura N. Infinger 1/8/1972 W/F. Brandt said he and Laura recently rented the apartment on Yacht Club Dr. He said they stayed the night with one another while alternating locations throughout the five years of dating prior to moving into the incident location. I asked Brandt where Laura was and he said he didn't know. It was later discovered she went upstairs to apartment 13 after the incident occurred. Brandt denied making any physical contact with Laura and suggested that she walked into the sliding glass door. Police Officer LeJeune stayed with Brandt while I made contact with Laura.

Upon making contact with Laura, I observed redness and swelling on her right cheek. She was crying and holding a tissue to her bottom lip. Laura said her lip was bleeding and opened her mouth for me to see a swollen lower bottom lip. I asked her if she needed medical attention to which she declined. Laura had a strong odor of an unknown alcoholic beverage emanating from her person when she spoke. During my investigation Laura advised she and Brandt had a verbal argument that led to Brandt throwing her down on the bed and open hand slapping her repeatedly. She advised they have been dating for about two years and he stays with her on occasion.

I spoke with the complainant, Leah, and she advised during the incident she heard three or four "slapping" sounds and a woman yelling "why are you doing this?" Leah said she did not witness any physical contact between Brandt and Laura.


Laura filled out and signed an Affidavit of Prosecution. Pictures of her injuries were taken by Police Officer LeJeune. She completed a Domestic Violence Risk Assessment screen. Laura was given a North Palm Beach Police Department case number with my contact information attached.

The results of my investigation lead to the arrest of Brandt for Simple Battery, F.S.S. 784.03 (1) (A) (1). The handcuffs were double locked and checked for proper fit. He was searched prior to being placed in my patrol car. He was transported to the Palm Beach County Jail without incident.


The pictures were submitted into temporary evidence for trial. There is nothing further to report at this time.
