On May 24, 2017, I responded to 67 W Coconut Dr, located in unincorporated Lake Worth within Palm Beach County FL, in reference to a Domestic.

Upon arrival, I made contact with Nicole Kennedy who stated that she was in an argument with her boyfriend Stephen Thomas Truscinski over finances in the kitchen. Kennedy stated that during the argument with Truscinski it turned violent. Kennedy stated that he became enraged towards her and he began slapping her with an open hand on the left side of her face approximately three times (No Marks Were Observed on Kennedy).

Kennedy stated that when Truscinski slapped her and screamed at her she was in fear for her life during which time she grabbed a knife from the kitchen and told him to get away from her in self defense. Once Truscinski backed off she put the knife down and he continued arguing with her soon after. Kennedy stated that she and Truscinski have been living together for the past two years. D/S Wise took a video recorded statement from Kennedy and Cpl. Diejuste took photos of the residence.

When I entered the residence I observed over 50 empty beer bottles all over the living room table and also on the kitchen counter. I also observed a rear broken window.

I asked Truscinski what happened and he stated that he did not want to talk to me.

Based on my investigation Probable cause exist to charge Stephen Thomas Truscinski with F.S.S. 784.03(1) Domestic Battery because Truscinski knowingly and willfully touched and or struck his girlfriend Nicole Kennedy against her will.

Truscinski was handcuffed which were checked for tightness and double lock and placed in the rear of the patrol vehicle without incident.
