## PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:

On the above date and time while stopped in the inside eastbound lane of W. Gateway Blvd, at the intersection of High Ridge Rd, I observed a dark blue Audi bearing Florida tag IBPF74 driving westbound in the eastbound lanes through the above intersection. Let it be noted that this incident occurred within the City of Boynton Beach, Palm Beach County, Florida. The vehicle continued westbound into the opposite left/north turn lane, passing me directly to my left. As the vehicle passed me it struck the lifted concrete median with its front right tire. Due to the vehicle's behavior and safety of all the drivers traveling eastbound on W. Gateway Blvd, which traffic was medium at this time, I made a quick uturn and attempted to conduct a traffic stop on the vehicle. The vehicle refused to immediately stop and pull over but instead continued westbound at approximately 20mph. I continued to chirp my siren to my vehicle numerous times, especially as the vehicle was traveling towards oncoming vehicles. After approximately 100 feet the vehicle finally stopped.

I then made contact with the driver/sole occupant W/M Markovic, Stevan (12/23/63), whose face was red flushed and sweaty. Markovic's eyes were large, bloodshot and glassy. I asked Markovic if he was okay, which he apologized that he took a wrong turn. Markovic advised that he was coming from Las Olas, Ft Lauderdale and was heading home. While Markovic was retrieving his credentials he appeared to be confused and unsure of the locations to his documents. While speaking with Markovic I detected the odor of an unknown alcoholic beverage emitted from his breath, which intensified as he spoke. Markovic's speech was thick and slurred. At this point of my investigation I asked Markovic to exit the vehicle, which he agreed to. As Markovic walked towards the front of my vehicle he swayed side to side. While speaking with Markovic outside of his vehicle I still detected the odor of the unknown alcoholic beverage emitting from his breath. Markovic's appearance did not change. I asked Markovic if he has consumed any type of alcoholic beverages tonight, which he stated yes. Markovic advised that he had one IPA 14oz beer and that was it. At this point of my investigation I requested Markovic to submit to a Series of Standardized Field Sobriety Task, which he agreed to. Prior to beginning I asked Markovic if he had any injuries and/or disabilities I should be aware of, which he stated no. See the following:

Pen Exercise: During the task Markovic swayed side to side, numerous times. Markovic had a difficult time following the stimulant with his eyes only, without moving his head. There were times that Markovic would not move his eyes at all.

## **WALK AND TURN:**

The following task was demonstrated and explained to Markovic, which he stated that he understood. During the instructional stage Markovic swayed side to side. Markovic lost his balance numerous times and started the task too soon. During the walking stage Markovic took 12 forward steps in a normal walking manner, missing every heel to toe steps and utilizing his arms for balance. Markovic stepped off the line on step number 7. Once Markovic reached step 12 he looked at me and stared. I asked Markovic if he was done, which he stated "yea". Task was not completed.

## ONE LEG STAND:

The following task was demonstrated and explained to Markovic, which he stated that he understood. During the instructional stage Markovic swayed side to side. During the balancing stage Markovic raised his right feet, raising it only 2-3 inches from the ground. Markovic dropped his foot numerous times, swayed side to side, used his arms for balance and lost his balance at one time.

#### **FINGER TO NOSE:**

The following task was demonstrated and explained to Markovic, which he stated that he understood. During the instructional stage Markovic swayed side to side. During the exercise stage Markovic missed the tip of his nose on the first RIGHT command. Markovic was breathing heavily and kept opened his move stretching his jaw and tongue.

## ROMBERG/ALPHABET:

The following task was demonstrated and explained to Markovic, which he stated that he understood. During the instructional stage Markovic swayed side to side. During the exercise stage Markovic advised that he did not feel comfortable recited the English alphabet, therefore I had Markovic count from 26 -51. Markovic counted to 47 and stop; repeating number 33 twice. Markovic then opened his eyes and advised that he was done.

Based on the above facts, Markovic was placed into custody under suspicion of DUI (D/L and Spaced). Markovic was then placed in the back seat of vehicle 4550 (Officer Donnino) and was transported to the Palm Beach County BAT facility. Officer Donnino and I arrived at the facility at 2330hrs, started my 20 minutes observations at 2335hrs and completed it at

2255hrs. Upon completion I requested Markovic to provide a sample of his breath to determine the alcohol content, which he agreed to. Markovic provide two accurate breath samples which were .156 and .156. I then read Markovic his Miranda Warnings, which he stated that he understood. Markovic completed the Q & As. Investigation was completed at this time.

Based on the above facts I've established Probable Cause to arrest Markovic with 1M count of DUI > .15 BAC (Enhanced) F.S.S. 316.193(\$)(4). Markovic was processed and later TOT PBCJ.

Incident was captured via BWC, no in-car video. Markovic's vehicle was removed from scene by Beck's Towing.
