D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
Officer Lopez observed Cripps' vehicle, a 2015 Mazda bearing Florida License Plate AFWP22 turning onto Loxahatchee River Road from Center Street. Officer Lopez verbally advised me that he observed Cripps' vehicle travel completely in the left hand side of the roadway over the traffic markings. Upon making contact, Officer Lopez advised me he observed bloodshot glassy eyes and the odor of an unknown alcoholic beverage. Officer Lopez also stated that it appeared as if Cripps had urinated on himself.

OBSERVATION OF DRIVER:

Cripps had bloodshot, glassy eyes. As I had Cripps walk towards my vehicle, he lost his balance to the right as he pulled his pants up and made contact with me as he regained it. Cripps had a noticeable wet spot on the back of his pants around the crotch and upper legs.

DRIVER'S STATEMENTS:

Cripps stated he had consumed two beers at Ale House. I asked Cripps on a scale of 1-10 how intoxicated he felt. Cripps answered, "3".

ODORS:

Odor of unknown alcoholic beverage on breath.

ATTITUDE: Cooperative, polite

CLOTHING: Purple button up shirt tucked in to Blue slacks with black dress shoes



Had some difficulty following stimulus, was moving head had to be reminded to use eyes only on several occasions.

WALK & TURN:

Cripps lost his balance at least twice during the initial phase. Cripps started too soon two times. Cripps stopped after each step to gain his balance. On the 7th step, Cripps lost his balance to the right, used his arms for balance, and stepped off the line. Cripps stopped after the 9th step and asked what to do. I reminded him to turn and continue. Cripps missed heel to toe on every step. Cripps used his arms for balance and stopped several times during the return leg.

ONE LEG STAND:

Cripps immediately began using his arms for balance. Cripps put his foot down at "1000-7" and stopped. I reminded Cripps to continue. He started counting over. Cripps was swaying visibly throughout the task. Cripps used his arms for balance at "1000-8".

FINGER TO NOSE:

L1: Cripps touched his nose to the left of the tip. Cripps did not put his finger back down. I reminded Cripps to put his finger back down to the side. R2: Cripps touched the tip of his nose. Cripps did not put his finger back down. I reminded Cripps to put his finger back down to the side. L3: Cripps touched to the right of the tip. Cripps did not put his finger back down. 
