At approximately 2:15 pm on 11/18/17, I responded to the Gardens Mall (3101 PGA Blvd, PBG, FL), reference a report of a retail theft. Officer Matt Arnold (ID #441) was made aware, via mall security, that a white male had just stolen a pair of Versace sun glasses from Sun glass hut. The male was reported to have been wearing a blue dress shirt, dark dress pants, and pink tie. See Officer Arnold's supplement for further. Officers advised that the male was last seen in Macy's. I entered lower level Macy's (3101 PGA Blvd, PBG) and observed a male matching the description of the suspect. I approached him and asked if he had ID on him. He said no, and then ran away from me east bound back into Macy's, away from me. At this time I was wearing my PBGPD uniform. I called out on the PBGPD radio that the male was fleeing. I took chase. Officer Chris Baez (ID #424) came towards us from the opposite direction and detained the suspect (later identified as Steven Daniel Firestone). The male was than placed under arrest for resisting arrest. He was searched incident to arrest. In his possession was a white plastic Macy's bag. In that bag was several pairs of glasses, and two bottles of cologne. All items had tags on them, and the male had no receipts in his possessions. After being read his Miranda Rights, he stated that he did not know where any of the items in the bag (in his possession) came from. One of the pairs of glasses was a black Versace glasses with silver in the rims. The Sunglass hut representative (Ashton Braun) confirmed that these were the glasses which the suspect had stolen. A show up was conducted, and Braun confirmed that the male in custody (Steven Daniel Firestone) was the suspect which had stolen the glasses (see Officer Arnold's supplement for further). Sunglass hut advised that they wanted to pursue prosecution of the suspect for theft. They also provided PBGPD video evidence of the crime/suspect. The sunglasses were valued at \$295.00. I took Firestone to PBGPD, incident to arrest. While enroute to the station, PBGPD advised me that they had confirmed that Firestone had an extraditable warrant out of Martin County.

Also while enroute to the station, Officer Dave Kahn (ID# 310) took the other four pairs of glasses (with tags on them, and accompanied by no receipt) to Sears optical in the mall. He met with Sears Optical which confirmed that the other glasses were theirs. They will be providing video evidence of the suspect stealing the glasses. They also provided receipts for the value of the glasses. The total amount of the glasses was \$714.00. The representative also confirmed that the suspect (based on the description) had been in to the store, and had claimed to be a Macy's employee. It should be noted that a Macy's name tag which read "Steve" was found in the male's possession. Sears confirmed that they also wanted to pursue prosecution. See Officer Kahn's supplement for further.

All videos, copies of receipts, and copies of video evidence were submitted into records and evidence at PBGPD.

Based of the above investigation, I have probable cause to charge Steven Daniel Firestone (FL DL F623-784-64-110-0) with:

Felony Retail Theft - with two or more prior convictions, under F.S.S. 812.015(2). Firestone has previous convictions out of Alachua (94/91), Broward (2/15/02), Palm Beach (4/23/97), St Lucie (5/30/91; 9/21/99; 2/25/16), Brevard County (7/1/99) and Martin counties (2/9/96; 9/13/02; 9/1/08). As well as the city of Juno Beach (4/23/97), the city of Lake Park (11/1/00). This charge is reference the theft at Sunglass hut (\$295.00).

Grand Theft - under F.S.S. 812.014(2) (C) (1), for the theft from Sears Optical (\$714.00).

And Resisting Arrest (without violence) under F.S.S. 843.02.
