


 On the 19 day of February, 2018 at 21:38 (Specifically include facts constituting cause for arrest.)

The following incident occurred in The City of Delray Beach, Palm Beach County, Florida;

On 02/19/2018 at 2116 hours I observed a white male, later identified as Steven Formhals via his PA DL, driving a black scooter (FL TAG: 3234RS) without proper eyewear. I conducted a traffic stop on the scooter at 800 W Atlantic Ave, the driver pulled into the Marathon Gas Station (725 W Atlantic Ave) and stopped. I approached the scooter and advised the driver of the reason for the traffic stop. Ofc. Bolanos arrived on scene and observed Formhals reach into his left pocket with his left hand and make a quick movement, as if he was throwing something. Ofc. Bolanos located a clear plastic ziptop baggie with a tan powdery substance, which he knew to be Heroin based on his training, knowledge, and experience, on the ground approximately two feet away from Formhals. Formhals was then placed into custody for further investigation. I checked the area and located another baggie with the same tan powdery substance inside, approximately 20 feet away.

I read Formhals his Miranda rights which he acknowledged and waived his rights. I asked Formhals about the clear plastic baggie and he stated that he threw the baggie because he has not been in trouble for a very long time. He has been clean from drugs for the last eight months. I asked what drug it was and Formhals said it was supposed to be Heroin. When asked about the second baggie, Formhals confirmed that he tossed two baggies. The second baggie was located approximately 20 feet away and it should be noted that there was a lot of wind. Formhals stated that he purchased the two baggies across the street from the gas station just prior.

Ofc. Bolanos tested the tan substance with an Opiates Reagent test kit, which tested positive for Heroin. The two baggies of Heroin were weighed at the Delray Beach Police Department and weighed 0.5 grams.
