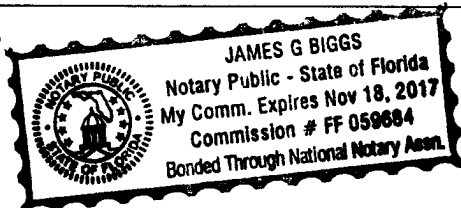

## PERSONAL CONTACT

### DRIVING PATTERN:

PL. VALERIO OBSERVED THE VEHICLES FRONT AND REAR TIRES ON THE WRONG SIDE OF THE ROAD WHILE HEADED WESTBOUND ON TEQUESTA DR. CPL. VALERIO ACTIVATED HIS EMERGENCY LIGHTS AT THE INTERSECTION OF TEQUESTA DR AND POINT DR. AND HE DID NOT COME TO A COMPLETE STOP UNTIL POINT DR. AND THE SECOND ENTRANCE TO BAY HARBOR.

### OBSERVATION OF DRIVER:

When making contact with the driver, (Steven Nardy) I could immediately smell the odor of an unidentified alcoholic substance emanating from Nardy's breath. I advised Rodgers that i was conducting a DUI investigation and requested consent to conduct SFST's. (Standard Field Sobriety Tasks) Nardy hesitated, then asked what would happen if he said no. I explained Taylor Warnings to Nardy, at that point he consented to performing the tasks. I escorted Nardy to the area where the tasks would be performed; during this time Nardy had a staggered walk and seem to have trouble keeping balance.

### DRIVER'S STATEMENTS:

Nardy did not state when he had a beverage last. Nardy did however stated multiple times that he had too much to drink but was trying to plead to let him go cause he was 2 blocks away from home. Requested a lawyer inside the Breath and alcohol testing center while i was requesting consent to take a breath test.
