PROBABLE CAUSE STATEMENT	<p>On 01-04-17 I was assigned a follow up investigation in reference to an unnatural / lascivious act that was reported to have occurred on a nature path at the Pond Hawk Nature Preserve just west of the Boca Raton Spanish River Library located at 1501 NW 40th St.</p>								
	<p>On 01-04-17 I was forwarded an email from a concerned citizen that had initially been sent to BRPD PIO Mark Economou. In summary, the message, sent via Face book, detailed an incident in which a female jogger, running on the nature path near the library observed a male subject masturbating while kneeling on the pathway the previous afternoon. The female identified as [REDACTED] was able to take a cell phone photo of the subject. The photograph was included in subsequent emails.</p>								
	<p>On 01-05-17 I met with [REDACTED] at the police department. [REDACTED] provided a sworn video recorded statement. In summary, [REDACTED] told me that on 01-03-17, at approximately 3:00pm, while jogging on the nature path on the west side of the lake near the Spanish River Library she observed an older white male riding a silver bike. [REDACTED] stated that she circled the jogging path three times. On the third time as she was about to exit the path she observed the older white male subject she had previously observed riding a bike kneeling naked on the pathway in front of her. She stated that she observed the subject masturbating. [REDACTED] was able to use her cell phone to take a picture of the subject. She stated that the subject got nervous and fled the area as she walked past him. She stated that the subject did not speak to her, attempt to touch her and did not prevent her from leaving the nature path. [REDACTED] stated that she returned home and told her husband what she had observed and then later reported it to the police.</p>




<p>additional report of a male subject described as a middle aged white male, about 5'10 grey / white hair wearing blue shorts and black or navy blue jacket. Refer to BRPD case number 2017-003443. The subject was previously observed riding a bike with a backpack wearing white shoes and white tube socks as described by [REDACTED]. The Officers had an enlarged photograph of the subject captured by [REDACTED] cell phone to help in possible identification. During their patrol through the park they came upon a subject later identified as Stewart Schiff that matched the matched the general description of the subject observed masturbating previously seen by [REDACTED] and the victim of the related incident. Schiff was in possession of a bike and backpack and looked similar to the subject captured by [REDACTED] cell phone. He was observed wearing white shoes and white tube socks as well as white and blue shorts and a dark polo style short sleeve shirt. Officer's Bremser and Campbell initially conducted a consensual encounter with Schiff which turned into Schiff being detained for a possible county ordinance violation. Schiff was detained by Officer's as he was suspected of riding his bike on the nature trails which is a violation of a Palm Beach County Ordinance. BRPD Officers contacted the Palm Beach County Sheriff's Office to respond to conduct an investigation into the violation of the ordinance. Schiff was detained in excess of one hour during the course of this investigation as it took PBSO a while to respond and walk into the nature preserve. BRPD Detective Scott Hanley and Mike Lamia responded and spoke with Schiff. Detective Hanley advised Schiff of his constitutional warnings. Schiff stated that he understood his rights and agreed to speak with the Detectives. The conversation was audio recorded. In summary, Schiff admitted to masturbating in the park. He stated that "I was back there and was masturbating but did not see anybody". He went on to say after being presented a copy of the photograph taken by [REDACTED] that "I can't believe that someone would take a picture of me doing that". Schiff did not provide any additional information helpful to this investigation. PBSO conducted an investigation into the county ordinance violation and concluded that as Schiff was not observed riding his bicycle, as required by the ordinance he was not in violation and was released from the scene.</p> <p>Stewart Schiff is charged with one count of exposure of sexual organs.</p>
