Probable Cause

On Friday, February 16th, 2018, I, Trooper Kuebler I.D. # 1614, was dispatched by Lake Worth Regional Communications Center (LWRCC) to a crash that occurred on SR-91 (FL Turnpike) southbound at the 117 mile marker, which is in Palm Beach County. I arrived on scene at approximately 8:52 PM where I observed a grey passenger car off the right hand paved shoulder of the roadway. I also observed a gentlemen on the other side of the guardrail leaning over it. At this time, I made contact with the Road Ranger identified hereafter as, William Corners, who was a wheel witness and was present at the time the aforementioned vehicle crash, that was later learned to actually be at the 124 mile marker, in Martin County.

Mr. Corners stated as he was assisting another vehicle southbound at the 124 mile marker, he witnessed the aforementioned vehicle that was being operated by a "tall elderly male" back into the

guardrail and what appeared to look like the driver of the vehicle attempting to turn back around and drive the opposite way off traffic. Mr. Corners, also advised the vehicle then continued back southbound on SR-91. Mr. Corners stated he also continued south on SR-91, and then shortly after, observed the same aforementioned vehicle pulled off the right side of the roadway, with the same driver he witnessed hit the guardrail, which is when he also pulled in directly behind him, at the 117 mile marker.

When I arrived on scene, I made contact with the gentlemen and later positively identified him by his valid Florida Driver's License as Stuart George Evans, date of birth 11/05/1959. Upon making contact with Mr. Evans, I could smell a strong odor of an alcoholic beverage emitting from his breath and person. Mr. Evans appeared that he was under the influence of some type of alcoholic beverage and or narcotics.

As I asked Mr. Evans for his driver's license and as he was getting it, he was fumbling around. Mr. Evans had a hard time standing up straight, as I was making contact with him in regards to the crash. Once I completed my traffic crash investigation, I then proceeded to begin a criminal investigation for the suspicion of Mr. Evans driving under the influence of alcohol and or narcotics.

At this time, I explained to Mr. Evans if he would be able to perform a series of Standard Field Sobriety Exercises (SFSE's), to which he understood and also complied. During the SFSE's, Mr. Evans performed poorly throughout the investigation. Mr. Evans was slurring his speech, unable to follow instructions and poorly performed the series of SFSE's that he was instructed to perform, which were the Horizontal Gaze Nystagmus (HGN) and Vertical Gaze Nystagmus (VGN), Walk and Turn, and One-Leg Stand with an additional exercise, which was the Finger to Noise.

At the conclusion of my criminal investigation for DUI, I placed Mr. Evans under arrest for suspicion of Driving Under the Influence of alcohol and or narcotics, at approximately 9:47 PM.

At approximately 10:50 PM, I transported Mr. Evans to hospital; Jupiter Medical Center to get medically cleared due to the fact he was in a motor vehicle accident.

At approximately 11:36 PM, Mr. Evans was cleared from the hospital and then transported to the Palm Beach County Jail. I arrived at the Palm Beach County jail at 12:07 AM, where I conducted a 20 minute observation of Mr. Evans, where he did not drink or ingest any foreign objects. At approximately 12:45 AM, Mr. Evans was advised of his Implied Consent. Warning, Mr. Evans initially refused to supply a breath sample, where he was then advised of the consequences of his refusal.

Finally, after Mr. Evans was advised of the consequences he then was willing to supply a breath sample.

The first breath sample was 0.154 and the second breath sample was a 0.159.

Mr. Evans was finally processed and booked into the Palm Beach County Jail for DUI.




