The following incident occurred in the City of Delray Beach, County of Palm Beach, Florida.

On 8/13/19 at approximately 1239 hrs, I was dispatched to the Delray Beach Public Library (100 W Atlantic Ave) in reference to a subject who pulled a firearm out on another patron. Ofc Hutchens was first on scene and detained the subject later identified as Suat Gokmen, who possessed the firearm. Hutchens removed the firearm from the pocket of Gokmen and made the firearm safe.

Upon arrival I met with the victim, Leroy Alford. Alford explained that he left some of his items on the table located on the north side of the library. Alford explained that he left for about an hour and returned noticing that his items had been moved. According to Alford he asked Gokmen why he touched and moved the items which were on the table. According Alford, Gokmen started a verbal argument. Alford explained that he called Gokmen an "asshole", at which time Alford stated that he believed Gokmen retrieved a black handgun from his bag, and put it on his person. Alford further explained that Gokmen pulled the firearm out of his pocket, and put it on his side in full view. According to Alford, he stated to the guy, "what are you going to shoot me?". Alford explained that he was in fear for his life, and wanted to prosecute for the offense. Alford was able to describe the gun as a black handgun.

Officers spoke with Gokmen post Miranda Warnings. Gokmen explained that a loud argument started over the items left on the table. Gokmen explained that he was afraid during the argument, and slightly pulled out the firearm from his pocket, to make sure that he had it on him. According to Gokmen he only slightly pulled the firearm out, but never fully pulled it out, and placed it by his side. Gokmen did verbally explain that Alford did not express any harm, or intent to become physically aggressive at the time of the argument, just was verbally loud. It should be noted that the holster to the firearm was
