


On 12/29/17 around 1905 hours, I was dispatched to 555 Arlington Drive in unincorporated West Palm Beach, Palm Beach County Florida 33415, in reference to an anonymous complaint of a suspicious white Lincoln parked along the canal with subjects possibly using drugs.

D/S Demario ID 29814 and I arrived in the area, and I observed a White Lincoln Town Car bearing Florida tag Y22NLL fleeing westbound along the canal with no lights on. I drove my patrol car towards Fergusson Lane and Dryden road, the only possible exit for the Lincoln, and observed it traveling southbound on Fergusson Lane with no lights on at a high rate of speed. It should be noted the vehicle was driving recklessly in a residential area where there were residents outside walking in the area. D/S Demario and I were able to safely catch up to the Lincoln and effect a traffic stop at S Jog Rd and Patricia Drive. Upon making contact at the vehicle, I could immediately smell the odor I recognized from my training and experience to be marijuana. The driver of the vehicle verbally identified herself as Ericka Domis, the front seat passenger as Summer Domis, and the left rear passenger as Dene English. All occupants were ordered from the vehicle one at a time. When Summer exited the vehicle she spontaneously shouted that the marijuana grinder, hash oil pen, and other drugs and paraphernalia were all hers.

A search of the vehicle revealed a silver marijuana grinder, glass pipe, bag of marijuana, and hash oil pen. The marijuana and hash oil pen later field tested positive for THC with a duquenois reagent field test kit. All vehicle occupants were separated and read their miranda warnings from a PBSO issued miranda card. All vehicle occupants said they understood their miranda warnings. Post miranda, Summer Domis admitted she brought all drugs and drug paraphernalia items in the vehicle for the purpose of the three girls smoking marijuana along the canal bank. Dene English and Ericka Domis corroborated Summers statement.

Based on my investigation I found Summer Domis be in violation of two counts of FSS 893.147(1)(b) Possession of Drug Paraphernalia, in violation of FSS 893.13(6)(b) Possession of Marijuana under 20 grams and in violation of FSS 893.13(6)(a) Possession of Schedule 1 Drug-Hash Oil.
