D.U.I. PROBABLE CAUSE AFFIDAVIT

ON THE 16TH DAY OF NOVEMBER 20 19, AT 0057 AM PM

SUBJECT: ROSALES SUZANNE MARIE CASE NUMBER: 19138112

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time, I was traveling East on Lake Worth Rd on routine patrol. I observed a blue Toyota 4 door vehicle traveling Eastbound driving erratically within its lane. The vehicle then made an abrupt turn into a left turn lane to enter a plaza on the North side of the road. The vehicle did not mke a left hand turn and continued to travel East into the Westbound lanes of Lake Worth Rd before braking and coming to a stop still in the Westbound lanes. As I made a U-turn to step out with the vehicle, I observed the vehicle reverse back into the break into the median before continuing Eastbound on Lake Worth Rd. I made another U-turn and got behind the Toyota bearing FL tag JYVQ43 and initiated a traffic stop on the vehicle. The vehicle yielded 2843 Lake Worth Rd.

I approached the vehicle and identified the driver as W/F Suzanne Rosales by her Florida Driver License.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by her Florida driver license as Suzanne Rosales, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and breath. This odor intensified as I spoke to her. She had glassy and blood shot eyes. Rosales' speech was slightly slurred and slow. Her movements were slow and deliberate. She had an unsteady gait while walking to my patrol vehicle and had difficulty following directions given to her. Rosales was wearing a black shirt, blue denim pants, and black high heels.

DRIVER'S STATEMENTS:

Pre-Miranda - Stated that she was coming from a funeral. Rosales stated that she had been drinking and just wanted to call someone to pick her up.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from her person and breath which intensified as I spoke to her.

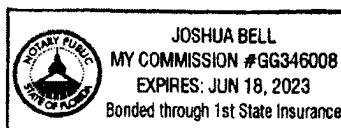

Other Observations:

Rosales would sway in a side to side front to back pattern throughout the task. Rosales was reminded numerous times to track the pen with her eyes only. She failed to keep her head still while tracking the stimulus.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to Rosales who stated that she understood. During the task, I observed her to sway in a side to side, front to back pattern throughout the demonstration phase. She could not maintain her balance while listening to instructions. She stepped out of the instructional stance during the demonstration to catch her balance. Rosales started the task before being instructed to do so. Rosales used her arms for balance by raising them more than six inches and did not touch heel to toe on any step during the task.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to Rosales who stated that she understood. During the task, I observed her to sway in a side to side, front to back pattern throughout the demonstration phase. She continued to sway while balancing on one leg. Rosales used her arms to balance raising them more than 6 inches from her sides. Rosales put her foot down to regain balance before the 30 seconds had elapsed. She then stopped the task on her own before the 30 seconds elapsed.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to Rosales who stated that she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. She did not keep her eyes closed. Rosales' index finger did not touch the tip of the nose on 2 of 6 attempts. She used the hand other than that which was called twice before self-correcting to the proper hand. The sequence used for this task was L, R, L, R, R, L.

ROMBERG ALPHABET:

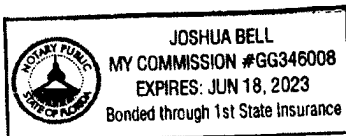
I explained and demonstrated the instructions for the "Rhombert Alphabet" task to Rosales who stated that she understood. During the task, I observed her to sway in a side to side, front to back pattern throughout the demonstration phase. She would sway more than 2 inches. Rosales stated that she was not comfortable reciting the alphabet but was comfortable counting from 1-26. Rosales correctly counted but did not keep her eyes closed during the task.
