On Saturday, 07/21/2018, at approximately 0058 hours I was leaving the District 6 substation when I heard a loud noise from a vehicle that drove by me on Jog Rd heading Northbound. The vehicle sounded as if it had a flat tire. As I drove behind the vehicle it started to slow down to approximately 10 miles per hour. I contacted dispatch in order to conduct a traffic stop to ensure the drivers safety. As I approached the vehicle I made contact with the driver, Suzanne Scherer W/F, who told me she blew out one of her tires. She said she lived down the road and was trying to get home because she did not know how to change a tire. At that time I asked her to move her vehicle off the road and turn into the subdivision that was directly beside the vehicle. As she backed up she was unable to follow simple commands and that is when I realized she was impaired. She got out of the vehicle and sat on the curb while I asked her simple questions. During my investigation I found out she was driving on the flat tires approximately 20 minutes as she was driving from Boca Raton. She was unable to say how she got the flat tires. I then called for a DUI unit. D/S Lynch ID#8568 arrived on scene.

**PERSONAL CONTACT**

**DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)**

On 7/21/18 I responded to Jog Rd/ Azura Lake Rd., in Palm Beach County in reference to a traffic stop with a possibly impaired driver. Upon arrival I met with D/S B. Clayton id 28990, who conducted the traffic stop.

D/S Clayton advised me that while leaving the district 6 substation she could hear loud thudding sound coming from a passing vehicle, a blue Mazda CX-9 SUV, bearing FL tag BUVX21. D/S Clayton got behind the vehicle and it slowed to approximately 10mph in the 45mph zone. D/S Clayton noticed that the vehicle had a flat tire and conducted a traffic stop to check on the driver. D/S Clayton made contact with the driver, Suzanne Scherer, the sole occupant of the vehicle. Scherer stated that she had just got a flat tire and was trying to get home because she lived close by. D/S Clayton advised Scherer to pull into the neighborhood so she was off the roadway. Scherer then backed a few feet and parked the car still in the roadway. D/S Clayton again made contact with Scherer and noticed that she was unable to follow simple instructions and believed she may be impaired. Scherer then changed her story stating that she had been driving on the flat tires for the past 20 minutes.

**OBSERVATION OF DRIVER:**

I met with Scherer, who was sitting on the curb. I asked Scherer for her license, which D/S Clayton advised she had given back to Scherer, but she was unable to locate it. Scherer fumbled with items in her purse while attempting to locate her license and her movements were uncoordinated. I noticed that Scherer's eyes were red and glassy and there was an odor of an unknown alcoholic beverage coming from her breath, which got stronger when she spoke. I had Scherer walk to the front of my patrol car. I noticed that Scherer was unsteady and swayed while standing still. I asked Scherer how she had gotten the flat tires and she advised that she had stuck a curb but was unable to advise where she had stuck the curb. Based on my observations I ask Scherer to perform standard field sobriety tasks, to which she complied.



**Other Observations:**

Scherer was asked to stand with her feet together and place her hands by her sides. Scherer was asked to focus on the stimulus and follow it with her eyes. Scherer was told not to move her head to assist in following the stimulus. Scherer showed equal pupil size that tracked equally. Both eyes lacked a smooth pursuit. I saw distinct and sustained Nystagmus at maximum deviation and onset of Nystagmus prior to 45 degrees in both eyes. Scherer swayed while performing this task and had to be reminded multiple times not to move her head.

**WALK & TURN:**

Scherer was placed in the instructional stance for the walk and turn task. I utilized yellow tape to make a straight level line, free from debris, which Scherer advised she could see. I explained and demonstrated the task to Scherer. During the instructions Scherer was unable to maintain the instructional stance and stepped out of the position several times. After completing the instructions Scherer advised she understood. During the task Scherer stepped off the line multiple times and missed heel to toe steps multiple times. Scherer used her arms for balance and paused to steady herself several times, after almost falling over. Scherer did not turn as instructed and almost fell over. Scherer took the incorrect number of steps, taking 13 steps in each direction.

**ONE LEG STAND:**

Scherer was placed in the instructional stance for the one leg stand task. I explained and demonstrated the task to Scherer. After explaining and demonstrating the instructions Scherer advised she didn't understand. I then explained and demonstrated the task to Scherer a second time and Scherer then advised she understood. During the task Scherer swayed and used her arms for balance. Scherer put her foot down several times prior to 30 seconds elapsing.

**FINGER TO NOSE:**

Scherer was placed in the instructional stance for the finger to nose task. I explained and demonstrated the task to Scherer. After explaining and demonstrating the task Scherer advised she understood. During the task Scherer missed touching the tip of her nose and failed to return her hand to her side after touching her nose several times. Scherer failed to keep her eyes closed and head tilted back even after being instructed to do so multiple times. After being instructed to bring her hand back down after the third right command Scherer touched her nose with her left hand, without being instructed to do so.

**ROMBERG ALPHABET:**

Scherer was placed in the instructional stance for the Romberg alphabet task. I explained and demonstrated the task to Scherer. After explaining and demonstrating the task Scherer advised she understood. During the task Scherer swayed while performing the task.
