

On 11-12-2016 at approx. 1725 hours I was stationary in a marked BBPD police vehicle conducting an Extra Patrol at the south/east Main entrance to the Boynton Beach Mall located at 801 N Congress Ave. I observed a red Ford fiesta bearing FL tag#DNPY40 traveling south bound at approx. 35 MPH that did not slow or yield to the pedestrian traffic at the edge of the painted crosswalk. The pedestrian traffic visibly responded to the vehicle by breaking stride and abruptly stopping to avoid be collided with. I activated my emergency lights and pulled in behind the vehicle. It initially did not slow or show any indication that it was going to stop. Based on the drivers actions or lack thereof and seeing more pedestrian traffic in the path of the vehicle I activated my emergency siren. The driver of the vehicle then acknowledged my presence (driver could be seen looking backwards via the rear view mirror) and began to slow but not yield to the right. The vehicle instead continued to slow and then stop at a stop sign after I gave commands via my vehicle PA to stop. I then made contact with the driver and sole occupant of the vehicle who was identified by FL/DL as w/f Suzanne M Sinn. I identified myself and advised Sinn of the reason for the traffic stop. I observed that the vehicle was still in drive and requested she place it in park and she complied. Sinn appeared lethargic and unaware of her actions and appeared to need to contemplate any requests before acting on them. I could smell the odor of alcoholic beverage coming from the cabin of the vehicle which intensified when she spoke. When she spoke she seemed confused and took longer than expected to respond and appeared to have thick slurred speech. She had blood shot and watery eyes as well. I asked her if she had been drinking and she replied "no". I pointed out that I could smell the alcohol and she stated "I had two beers". She provided her D/L and insurance but I had to request her registration a second time. When she did provide the registration she also gave me several unrelated documents as well. I walked back to my patrol vehicle leaving Sinn in her vehicle and requested the assistance of a DUI officer. Ofc Castro responded and took over the DUI investigation which led to the arrest of Sinn.

**PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:**

On the above date and time I responded to 801 N. Congress Ave (Boynton Beach Mall) in reference to a Traffic Stop conducted by Officer Monteith. Let it be noted that this incident occurred within the City of Boynton Beach, Palm Beach County, Florida.

Upon arrival I made contact with Officer Monteith who advised that while conducting an Extra Patrol at the east main entrance to the mall he observed a 2013 Red Ford Fiesta bearing Florida tag DNPY40 traveling southbound through the pedestrian crossway at a high rate of speed. Officer Monteith advised that he estimated the vehicle to be traveling approximately 35mph through the fully occupied crossway. Officer Monteith advised that due to the vehicle failing to yield for the pedestrian, pedestrians had to quickly move out of the way for the vehicle, in fear of being struck. Officer Monteith advised that due to the vehicle's actions he activated his emergency lights and sirens and attempted to conduct a traffic on the vehicle. Officer Monteith advised that the vehicle failed to quickly yield to his emergency equipment and after traveling approximately 100 yards behind the vehicle, repeatedly pressing his air horn and utilizing his PA system, the vehicle finally stopped. Officer Monteith advised that he then made contact with the driver/sole occupant of the vehicle W/F Sinn, Suzanne (10/29/68) and explained to her the reason for the traffic stop. Officer Monteith advised while speaking with Sinn he detected the odor of an unknown alcoholic beverage emitting from Sinn's breath, which intensified as she spoke. Officer Monteith advised that Sinn spoke with a thick slurred speech and her eyes were bloodshot/glassy. Officer Monteith advised that Sinn appeared to be lethargic and slow when responding to his questions. Officer Monteith advised that due to Sinn's appearance, believing that she was under the influence while operating a motor vehicle, he contacted me to continue the investigation. See Officer Monteith supplement for further.

I then made contact with Sinn, who was still sitting in the driver seat of her vehicle. I identified myself to Sinn and reassured that she understood why the traffic stop was conducted on her, which she stated that she understood and admitted to her driving infractions. While briefing speaking with Sinn, I observed the same indicators as Officer Monteith did. I asked Sinn if she had any type of alcoholic beverage today, which she stated she two beers. Based on my investigation at this point, I properly positioned my vehicle so that I could properly conduct an audio/video recorded investigation. I then asked Sinn to exit her vehicle and requested that she walked to the front of my fully

marked patrol vehicle (4445), which she agreed to. Once in front of my vehicle, I advised Sinn that the investigation was being audio and video recorded, which she stated that she understood. I then advised Sinn that one of the reason I requested that she exited her vehicle was because I detected the odor of an alcoholic beverage emitting from her breath and within the vehicle and I wanted to clarify where the odor was coming from, which she stated that she understood. At this point while speaking with Sinn I still detected the odor of the alcoholic beverage emitting from her breath, which still intensified as she spoke. I asked Sinn what type of alcoholic beverage she had, which she stated 2 beers. She then stated 2 Bud Lights. At this point of my investigation I requested Sinn to submit to a series of Road Side Sobriety Task, which she agreed to. Let it be noted that prior to starting the exercises I asked Sinn if she had any injuries and/or disabilities which he stated yes. Sinn advised that she had arthritis in her hands and knees. **WALK AND TURN:**

The Task was explained and demonstrated to Sinn, which she stated that he understood. During the instructional stage, Sinn could not stand in the manner I requested of her. Sinn began to the task to soon more than one time. During the walking stage, Sinn took 9 steps forward in a normal walking manner. Sinn missed heel to toe on every step, stepped off the line to the right on step 2, paused for balance and raised her arms for balance. Sinn conducted an improper turn. On the returning 9 steps, Sinn continued in a normal walking manner. Sinn missed heel to toe on every step and raised her arms for balance. Did not count her steps out loud.

**ONE LEG STAND:**

The Task was explained and demonstrated to Sinn, which she stated that he understood. During the instructional stage, Sinn swayed side to side. Sinn advised that she would not be able to complete the task due to her arthritis. During the balancing stage, Sinn raised her left foot and dropped it on count # 2,3,9,10,11. Sinn then counted #10 again and dropped her foot. Sinn then lifted her right leg, continuing to count from #10, dropping her foot on #16,17. Sinn used her arms for balance.

**FINGER TO NOSE:**

The Task was explained and demonstrated to Sinn, which she stated that he understood. During the instructional stage, Sinn sway side to side. During the exercise stage, Sinn missed the tip of her nose on the first Left Hand command. On her last Left Hand command and on her first Right Hand command she touched her nose with the middle of her finger. On the third Right Hand command Sinn used the wrong hand.

**ROMBERG/ALPHABET:**

The Task was explained and demonstrated to Sinn, which she stated that he understood. During the instructional stage, Sinn sway side to side. During the exercise stage, Sinn did not feel comfortable recited the alphabet therefore I requested that she counted from 26-56. Sinn swayed side to side while counting, failed to keep her eyes closed through-out the entire time she was counting.

At that time, Sinn was placed into custody under suspicion of DUI, placed into handcuff (D/L and Spaced) and placed in the back seat of my patrol vehicle (#4445). I then transported Sinn to the Boynton Beach Police Department for processing. I arrived at the Boynton Beach Police Department at 1809hrs, started my 20 minutes observation at 18108hrs and completed at 1830hrs. Upon completion I requested Sinn to provide a sample of her breath to determine the alcohol content, which she refused. I then read Sinn Implied Consent; which she stated that she understood. I then requested Sinn a second time for a sample of her breath to determine the alcohol content, which she refused again. I then read Sinn her Miranda Warning, which she stated that he understood. I asked Sinn if she was willing to answer the questions on this packet, which she agreed to. See questions on pocket for further.

Based on the above stated facts I have established Probable Cause to charge Sinn with 1M count of DUI pursuant with F.S.S. 316.193.1.

Sinn was cited by Officer Monteith for failing to yield the right of way to pedestrians and speeds too fast for condition.

SFST Video and BAT Video was later placed into BBPD Evidence. Sinn's vehicle was removed from scene by a family member.
