<p>On the above date and time, I responded to 3600 N Old Dixie Hwy in unincorporated Delray Beach, FL in reference to a domestic disturbance.</p> <p>The caller, Shawn Culp advised PBSO Dispatch that his mom (Tabatha Brumbaugh) and his Step dad (Brett Brumbaugh) had gotten into a fight on the back patio on of the home, and he has locked himself in his room. Prior to my arrival, Shawn advised that Brett had left the residence in his truck.</p> <p>On my arrival to the residence I spoke with Tabatha. Tabatha advised that both her and Brett had been drinking tonight and that Brett is an alcoholic. Tabatha advised that they got into an argument after Brett brought up her infidelity. Tabatha said that Brett then "came at her" and she said she had to push him back to stop him from attacking her. Tabatha said that Brett sprayed her with lighter fluid and she had to push him back and threw the can back at him. Striking him with it. I was not able to observe any visible markings on Tabatha, nor did I smell lighter fluid on her person, I did observe a can of lighter fluid on the floor of the patio area.</p> <p>When I spoke with Shawn, He advised that he heard Tabatha and Brett arguing but was not able to see the whole incident and only heard them arguing. Shawn said that they began arguing about a boat.</p> <p>D/S Chahine was able to locate Brett at a nearby gas station and Brett came back to the residence to speak with me. Brett advised that he did began arguing with Tabatha about her infidelity, and that Tabatha became so irate that she starting pouring lighter fluid on him and threw the can at him and striking him on the face. Brett had a very visible wound on his left forehead with fresh blood. Brett also had several scratch marks on his person which he explained was from Tabatha attacking him from being upset about the argument. Brett advised that he tried to defend himself by pushing her back. Brett also had a visible fresh scrape on his knee which he said was from the incident. Brett refused to give a sworn statement or let us take pictures of his person due to him not wanting Tabatha to go to Jail.</p> <p>Due to the extensive visible injuries on Brett's Person and no injuries on Tabatha, I find probable cause to Charge Tabatha 1 count of F.S.S. 784.03(1)(a)(1) in which she did intentionally strike Brett Brumbaugh against his will.</p>
