## PROBABLE CAUSE

On November 12, 2017 I was on routine patrol in Palm Beach County in my marked patrol vehicle. I was called to assist Palm Springs Police Department with a vehicle crash and possible DUI investigation. I arrived on the scene of the vehicle crash that occurred on Lake Worth road and Congress Ave. I arrived on scene and observed multiple police and fire rescue vehicles along with a dark colored expedition facing eastbound in the westbound lanes of Lake Worth road. Upon further investigation I observed that the expedition had obvious rear end damage from a collision. Upon further investigation I learned from the investigating officer that the expedition had been rear ended by a white pickup truck. I continued westbound on Lake Worth road and observed that there was a white pickup truck stuck in a retention pond to the right of the westbound lanes approximately .5 miles from the original area of collision. I observed that the vehicle had obvious front end damage from a collision then observed that a white female was being loaded into a fire rescue truck. I then entered the rescue truck and observed that the female had obvious marks consistent with airbag deployment. I also observed that the female had bloodshot glassy eyes and the obvious odor of an unknown alcoholic beverage was emitting from her breath. She was then transported to JFK Medical center. She was later identified as Tabatha Sanders by her Florida DL. An independent witness Christopher Coombe gave a sworn statement stating that he observed a white Chevy Silverado travel westbound on Lake Worth Road with obvious front end damage and the hood up. He then observed the vehicle exit the roadway and crash into the pond. He then went over to the vehicle and observed a white female who was later identified as Ms. Sanders exiting the vehicle from the passenger side. Upon further investigation I observed that the driver side door of the vehicle had obvious damage and was unable to be opened. I then proceeded to JFK medical center and observed again that Ms. Sanders had bloodshot glassy eyes and the odor of an unknown alcoholic beverage emitting from her breath. I then advised her that I was not investigating the traffic crash and that I was there to conduct a criminal DUI investigation. She stated that she understood. I then read Ms. Sanders her Miranda warning from my state issued card. She stated that she understood. I then requested that she perform Field Sobriety exercises and she refused. After talking with the medical staff at the hospital, due to the medical testing in the hospital and the fact that she will not be released for an extended period of time, I decided that requesting a breath sample was impractical and request that Ms. Sanders provide a blood sample. She then refused. Implied consent was read and she stated that she understood implied consent. She then refused to provide a breath sample again.

At approximately 1:05am she was placed under arrest. She was then transported to the Palm Beach County Jail.  
The above incident occurred in Palm Beach County.
