On April 13, 2018, at approximately 1540 hours, I responded to 3200 Old Boynton Rd, Boynton Beach, FL (Walmart) In reference to a shoplifting in progress.

Upon arrival I made contact with Walmart LPO David Hernandez. LPO Hernandez stated that at approximately 1520 hours a two white females later identified as (Tabitha Gould and Elizabeth Thibault) entered the store. Both were seen walking through out the store concealing multiple clothing items. Gould and Thibault then exited the store, passing all points of purchase with the items concealed. Gould and Thibault were intercepted by Walmart LPO's in the parking lot of the store. The total value of merchandise Gould attempted to take is \$345.00 and the total value of merchandise Thibault attempted to take is \$109.00. LPO Hernandez provided a sworn statement which was captured via body worn camera at marker 0:30 as well as surveillance footage of this incident. LPO Hernandez issued Gould and Thibault a verbal trespass warning which was captured via body worn camera. Gould and Thibault stated that they understood the terms of the trespass. The total amount of stolen items taken by Gould are as follows,


51 pairs of shirts, shorts, and leggings, Total value \$345.00

Total value of items stolen by Thibault are as follows,

8 pairs of athletic shorts, value \$109.00

At this time probable cause exists to arrest and charge Thibault with Retail Theft in violation of F.S.S 812.015 (2). Thibault was processed on scene and released with a notice to appear. Probable cause exists to arrest and charge Gould with Retail Grand Theft in violation of F.S.S 812.015(8). Gould was transported to BBPD for processing before being TOT the care and custody of the Palm Beach County Jail.
