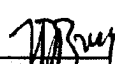

	N A R R A T I V E Upon arrival, I made contact with the victim, identified as Elias Ricardo Mojica, who was standing in the driveway. Mojica stated that he lived at the residence with his wife, Tania Lamanna. Mojica went on to state that they were in a verbal argument regarding their divorce and in the middle of the argument he decided to walk out of the front door and leave. Mojica stated that Lamanna believed that he had her cell phone, so she followed him outside to get it back. Mojica then stated that Lamanna grabbed his shirt from the back of the collar and pulled him towards her, tearing his shirt. Mojica stated that he also received a cut on his forearm from the physical altercation. Mojica was observed to have a ripped t shirt and scratches on his right forearm. Mojica said that he went into the bedroom and found a camera that he did not know about and that prompted more arguing. Mojica advised that he never had Lamanna's phone and he only left to get away from the argument. Mojica stated that at no point during the dispute did he become physical with Lamanna. I then made contact with Lamanna, who was inside the house with their 5-year-old daughter, Liv Mojica. Lamanna advised that Mojica returned home today around 1800 hours and they began arguing. During the course of the argument Mojica took Lamanna's phone and threw it on the countertop. Lamanna stated that they kept arguing over missing items in the house when Mojica took the phone again and started walking towards the front door. Lamanna advised that Mojica went outside and she followed. This was in an attempt to retrieve her phone because she feared that he would throw it in the lake as he had done before. Lamanna stated Mojica was holding the phone over his head to prevent her from getting the phone, so she placed one hand on the collar of his shirt and reached for the phone with the other hand. Lamanna stated that Mojica moved his elbow backwards in an attempt to get her off of him and she fell down to the ground. Lamanna stated that Mojica then threw the phone in the grass where she retrieved it and went back inside. Lamanna stated that she screamed for help, but never made any attempt to retrieve help from a neighbor. I then spoke with Liv who was sitting in the living room while the altercation took place. Liv stated that her mom and dad were having an argument because her dad took her mom's phone. Liv said that she was not watching them when they were arguing next to the living room. Liv advised that when they went outside she saw her mom rip her dad's shirt. I attempted to make contact with the neighbors to see if they witnessed the incident. I attempted contact at 2413 NW 26th St, however, no one answered the door. I then made contact with the owner of 2420 NW 26th St, Marcia Muma, who advised that she did not witness this specific altercation, however, she advised that she has heard many arguments coming from 2425 NW 26th St. Muma stated that she can hear the arguments from inside of her house and that she normally only hears Lamanna screaming. Based on my investigation I placed Tania Lamanna under arrest for Simple Battery under F.S. 784.03(1A1) after she ripped the victim's shirt and scratched the victim's forearm. Lamanna was transported to the BRPD Booking facility for processing and later transported to the Palm Beach County Jail.

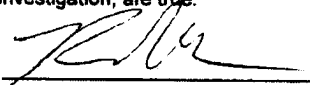
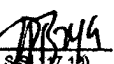
