On May 1, 2018, at approximately 1343 hours, I responded to Walmart located at 3200 Old Boynton Road, Boynton Beach, Florida 33435 in reference to a retail theft.

Upon arrival, I made contact with Walmart Loss Prevention Officer David Hernandez. Hernandez advised in a recorded sworn written statement that while on direct floor observation he observed a white female later identified as Tania Wolcott in the cleaning supplies department selecting various items and placing them in her cart and then subsequently proceeding to other store aisles and place items in her cart. Wolcott then proceeded past all points of sale and exited the store, failing to render payment for the concealed items. LPO Hernandez approached Wolcott outside of the store, detained her and escorted her back to the loss prevention office where the merchandise was recovered. Hernandez provided an itemized receipt and the subtotal of the items was \$114.03.

Based on the aforementioned, Tania Yolande Wolcott was placed under arrest for Felony Retail Theft pursuant to F.S.S. 812.015(1)(d)(2) due to having prior Retail Theft convictions on 9/12/2016 (Reference Court Case # 502016MM007663AXXXMB), 9/12/2016 (Reference Court Case #502016CF0022142CXXMB), 9/12/2016 (Reference Court Case # 502016CF002143CXXMB).

Wolcott was trespassed warned in my presence, forbidding her from entering Walmart for a period of one year from the date of this report. Wolcott acknowledged the trespass agreement.

Prior to a pat down being conducted on Wolcott advised she had syringes and spoon with white residue in her purse. Syringes and spoon were submitted into BBPD Evidence for destruction.

An NCIC/FCIC query was conducted for Wolcott and she was negative for wants and warrants.

Walmart receipt was submitted into transmittal. Hernandez's sworn statement and trespass warning was captured on my department issued body camera. This incident was captured on my department issued body camera.
