On 03/09/2018 at approximately 05:39 hours, I responded to 212 Gazetta Way, located within the gated community of Terracina, in Unincorporated West Palm Beach, Palm Beach County, FL, in reference to a possible burglary in progress. While en route to the call, PBSO Dispatch advised that Security Guards on site had a female in a white Dodge Charger unlawfully enter the community after being denied access at the guard gate. PBSO Dispatch then advised that Security Guards stated that the female was now trying to break into the house at 212 Gazetta Way by breaking the rear glass door to the residence.

Upon arrival, I met with D/S C. Morin #20337, to which we then approached the security guard, Krystal Singh, and asked what happened. She stated that an unknown female in a white Dodge Charger unlawfully entered the community after being denied access at the gate. She further stated that the female then has been trying to break into the home at 212 Gazetta Way by smashing the rear glass door. At this point, myself and D/S Morin began approaching the rear of the house to which I observed a white female, later identified verbally as Tanya Ravelo Rojas, walking around from the back of the house. I ordered the female to stop, to which she continued walking away from me. I ordered her a second time to stop right there, to which she ignored my commands and continued walking away from me towards the front door. I grabbed the subject by her right arm and again ordered her to stop and told her to place her hands behind her back. She pulled her arms away and said "I'm not resisting", as she resisted my efforts to take her into custody. I then pulled her arms back to which D/S Morin placed her in handcuffs, double-locked and checked for tightness, without further incident. The subject spontaneously uttered "I fucking live her, why are you arresting me." I asked the subject if she had any proof or documentation of residency of the property, to which she said no, and stated that she has some clothes inside that belong to her. I asked her for the name of the homeowner that gave her permission to be there, to which she said "William Rodriguez". I asked her for his age and/or birthday to which she was unable to provide one, but said that he is in his 30s or 40s. The subject was detained and placed in the back of the patrol car.

During the course of my investigation, I observed a white Dodge Charger, bearing FL Tag #WHP1M, parked in the driveway of the residence. The vehicle was registered to the subject and had dark scuff marks across the front driver side A-pillar and white scuff marks across the driver side rear window. These marks are consistent with the gate arm dragging across the vehicle while the vehicle was entering the community. I then checked the back of the residence and observed that the rear glass door was damaged, with pieces of wood and metal on the ground in front of the door. I also observed a chair, laying on its side, near the broken door. The total damages are approximately \$500. I took photos of the scene and entered them into evidence. I further obtained a sworn written statement from the security guard, corroborating her story. The security guard also confirmed that the subject is not listed as a resident/guest of any residence in the community, and further confirmed that the owner of the property is an "Edward D Thomas" and the renter of the property is a "Mary Varela".

I then researched the property through the Palm Beach County Property Appraiser's Office website, to which I confirmed that the owner is, in fact, Edward D Thomas. I further researched William Rodriguez in the age range of 30s-40s, and did not discover anyone utilizing that address in the PBSO PALMS system and/or DAVID system. Furthermore, I researched the address via the PBSO PALMS system and discovered that no William Rodriguez and/or Tanya Ravelo Rojas have this address listed for them. D/S S. Ith #9544 responded to the registered owner's address, located at 2212 Ridgewood Cir., in Royal Palm Beach, FL. Upon his arrival, he made contact with the owner of 212 Gazetta Way, Edward Thomas, to which the owner stated that Tanya does not have any right to be on his property. He further stated that he rents the property to Mary Varela, and that Tanya is not a renter and has no permission to be on site. He completed a sworn written statement corroborating the above. I called Mary Varela at the phone number provided (561-542-7213) numerous times, however, she did not answer the phone.

Based on my investigation, I determined that the subject did commit the following acts:

Attempted Burglary of an Unoccupied Dwelling, by knowingly and willfully attempting to enter the residence of 212 Gazetta Way, by smashing the rear glass door, causing approximately \$500 in damages, without the homeowner's permission, and with the intent to commit the act therein, pursuant to FSS 810.02(3)(b).



Criminal Mischief (\$200-\$1000), by knowingly and willfully smashing the rear glass door of the house, causing approximately \$500 in damages, without the homeowner's permission and with the intent to commit the act therein, pursuant to FSS 806.13(1)(b)(2).

Trespassing on Property other than a Structure, by knowingly and willfully entering a gated community with restricted access, despite being denied initial access by security guards, by following another vehicle inside, thus unlawfully occupying the neighborhood without invitation, permission, or authorization to do so, pursuant to FSS 810.09(1)(a).

Resisting Officer without Violence, by knowingly and willfully resisting lawful arrest by ignoring commands to stop, walking away from deputies in full PBSO uniform, and then pulling her arms away and refusing to comply with being placed in handcuffs, pursuant to FSS 843.02.

The subject became uncooperative and belligerent during the investigation and refused to answer basic questions such as her date-of-birth, height/weight, and phone number. As a result, these items were obtained through the PBSO PALMS system and other investigative resources. The subject then began to yell and scream obscenities at both deputies throughout the remainder of the investigation.

The subject was then booked at the PBSO Main Jail, without incident.
