## DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Sunday, April 16, 2017 at approximately 2320 hours, I responded to Congress and Clintmore Avenue, Boca Raton (Palm Beach County) Florida to assist Deputy Billy Rivera with a traffic crash that involved a possible drunk driver. Upon my arrival I noticed a red Ford Focus stopped in the median on Congress Avenue facing northbound. The vehicle's rear side was resting in the southbound lane of Congress Avenue. its right front tire was resting in the northbound safety zone on Congress Avenue. I made contact with D/S Rivera who told me the following: I was dispatched to 17800 south Congress Avenue in the unincorporated area of Boca Raton in reference to assisting an disabled vehicle causing a traffic hazard with no lights on.

Upon arrival, I made contact with a Boca Police Officer who advised that our complainant Roberto Huerta Jr. had just left the scene but provided his cell phone (904) 315-5532. I observed a red in color, 2016, Ford, Focus, four door, bearing FL tag CHW-T32 on the center median with under carriage damage. The vehicle was facing north bound on south bound lanes and there was oil coming from the bottom of the engine compartment. I observed the driver a white female who was the sole occupant of the vehicle who was sleeping. I immediately smelled an strong odor of an alcoholic beverage emitting from the interior of the vehicle and summoned for a DUI Investigator to respond to the scene.

I made contact with the complainant via cell phone Roberto Huerta Jr. Roberto stated while driving home from work he observed a vehicle stuck on the center median with the lights off. Concerned for the safety off the driver and the public Roberto stopped and made contact with the driver Shipley and asked her if she was o.k ? Roberto stated Shipley proceeded to cry and stated " Fuck everybody !" Roberto stated she was at a party and wanted Roberto to help her so she could go home. Roberto stated he felt Shipley shouldn't be driving so he removed the keys from the ignition and that was when Boca Police arrived on scene: D/S Rivera wrote a sworn witness statement on a probable cause affidavit regarding this incident.

## OBSERVATION OF DRIVER:

I made contact with the driver who was sitting in the driver seat of a red vehicle. She was fast asleep and not responding to any of my attempts to wake her. Her head was lying in her chest with her hair covering her face. I knocked on the roof o the car while calling her name. She remained motionless. I tried shaking her gently and she continued to be unresponsive. I applied a hard rub to her left shoulder and she began to respond. As I continued this method she awoke. I asked if she knew her present location and she mumbled inaudibly. Her speech was unclear and slurred. I told her I was a sheriff's deputy with the Palm Beach County Sheriff's Office. I asked her to remove her seatbelt and she struggled with locating it. Rather she began looking inside her purse. After some time she found the buckle and disengaged the seatbelt. While interviewing her I could smell a strong odor of an unknown alcoholic beverage emanating from the inside of the vehicle. Her eyes were watery and glossy. She appeared to be in a daze while having a blank stare in one direction. Her response to my questions was slow. She appeared to be intoxicated. I later identified as SHIPLEY TARA CHANDRASEKHARAN by her Kansas driver license. I explained to the her that I had a suspicion she had been drinking an unspecified amount of unknown alcoholic beverages. Moreover I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating and being in actual physical con a motor vehicle. She consented to performing the SFSTs. Prior to her exiting the vehicle I asked if she had any physical problems with her body that would inhibit her from performing light physical movements. I also asked if he was on medication. The defendant conveyed she neither had anything wrong with her physically, nor was she on medication. I asked her to exit the vehicle. When she exited she was unable to maintain her balance. She staggered toward me and I had to support her by grabbing her arm to keep her from falling. I escorted her to a smooth and level surface that was free from obstructions and debris. The area was well lighted by the lights from my patrol car and ambient lighting in the area. I could now smell a strong odor of an unknown alcoholic beverage coming from her breath which intensified when she spoke. The following SFSTs were intended to be administered: HGN, The Walk and Turn, The One Leg Stand, The Finger to Nose and The Romberg Alphabet Recitation. Due to safety concerns I only administered the Finger to nose. Her deficiencies were noted on a DUI worksheet.



**Other Observations:**

As she sat in the driver seat of her vehicle I asked her to focus on the stimulus and follow it with their eyes. Lastly they were told not to move their head to assist in following the stimulus with their eyes. The defendant had equal pupil size and equal tracking. During this task She lacked a smooth pursuit in both eyes. She had distinct and sustained jerking in both eyes at maximum deviation. She had an onset of nystagmus prior to 45 degrees. She often turned her head to assist her eyes in following the stimulus.

**WALK & TURN:**

The def was placed in the instructional stance for the Walk & Turn and given instructions. The def stated that they understood my instructions. Defendant could not maintain her balance while trying to assume the instructional position. She swayed and staggered out of the position. She began crying loudly. I allowed her some time to gather her composure. When we resumed I asked D/S Rivera to stand close by in case of the defendant falling. I decided not to administer this task for safety concerns.

**ONE LEG STAND:**

**FINGER TO NOSE:**

The def was placed in the instructional stance for the Finger to Nose and given instructions. The def stated that they understood my instructions. Subject swayed when placed in the instructional position. During this evaluation subject pointed her arm out to the side when given the command of "right" or "left". She also turned her head to the side of the command. She turned her head and pointed with the wrong hand on two occasions.

The def was placed in the instructional stance for the Romberg Alphabet and given instructions. The def stated that they understood my instructions.


