Tafe then confronted Dr. Dennis with the patient being unaware of the prescription to which Dr. Dennis stated that the patient must be confused. Beginning the end of December 2018, twelve of Dr. Dennis` other patients, whom had never previously received Zolpidem were listed as filling Zolpidem prescriptions at Publix store 4154 and paying without using insurance. :	On April 26, 2019 I spoke with Florida Department of Health Investigator Kathleen Healy-Baez. She told me she was also currently investigating a complaint regarding Dr. Dennis. Healy-Baez said she went to Publix store 4154 spoke to Tafe, Garcia and watched video of what appeared to be Dr. Dennis picking up several prescriptions on April 13, 2019. A check of Dr. Dennis` personal E-FORCSE shows she did not pick up a prescription for herself on this date or at this location. It should be noted however that Dr. Dennis did pick up a prescription for Zolpidem at CVS, written to her on April 12, 2019. On April 29, 1019 I began reaching out to several of Dr. Dennis` patients who were recently listed filling Zolpidem prescriptions at Publix store 4154. I spoke with Sarah Alexander who told me she did not fill any prescriptions at Publix Store 4154 and further did not have a prescription for Zolpidem from Dr. Dennis.
