	On April 29, 2017 at approximately 0315 hours, Tara Hogarty battered her mother, 67 year old Blanca Finnegan.										
	Hogarty currently resides with Finnegan at Finnegan's residence in Royal Palm Beach. This morning, Hogarty was standing in the front doorway with the door open. When Finnegan asked her to move inside or outside, Hogarty did not move. When Finnegan pushed Hogarty out of the doorway so she could close the door, Hogarty then came inside and began yelling at her mother. Finnegan tried to push Hogarty out of the residence because she was concerned Hogarty would hurt her, and instead Hogarty grabbed hold of Finnegan by her right arm and also by her hair, pushing Finnegan back.										
	As a result of Hogarty grabbing hold of Finnegan, Finnegan sustained a bruise to her right arm that was approximately the size of a quarter dollar. Finnegan also sustained a small laceration to her upper arm, and a small scratch to her upper lip under her nose.										
	Hogarty had no apparent injuries. Finnegan stated she believes Hogarty has some un-addressed mental health problems because Hogarty talks to herself, she sees and feels things that are not present, and she sometimes exhibits paranoid behavior.										
	Probable cause exists to arrest and charge Tara Hogarty with committing domestic battery upon a person 65 of age or older, in violation of FSS.784.08(2c).
