ripped in several places and her skin was red and irritated in appearance. Abitol stated Zapolin had been drinking and was becoming agitated.

Abitol stated she was trying to console her daughter when Zapolin became physically aggressive to her. Abitol stated Zapolin grabbed her by the shoulders and pushed her. Abitol stated Zapolin hit her with open hands in the right shoulder. Abitol stated Zapolin pushed and yelled obscenities at her until she was able to escape the residence.

Abitol agreed to having only two pictures taken of her and would not provide a written statement. Photographs were placed into evidence.

I arrived at unit 23-101 and spoke to Tara Zapolin. Zapolin stated she grabbed her mother and pushed her out of the house. Zapolin stated she was physical with her mom and she should not have hurt her mom. Zapolin stated she had been drinking and she wanted to be alone. Zapolin stated she grabbed her mom by the shirt and pushed her toward the front door. Zapolin stated she should not have hit her mom and began to cry.

Based on my investigation and the statements of Zapolin and Abitol, Zapolin was placed under arrest for Domestic Battery and Battery upon a person 65 years or older.

Zapolin did actually and intentionally strike her mother against her will contrary to FSS 784.03(1) Battery.

Zapolin did actually and intentionally strike a person 65 years or older contrary to FSS 784.08(2c) Battery on person(s) 65 years or older.

Zapolin was transported to Boca Raton Booking Facility to be processed. Zapolin was processed and transported to Palm Beach County Jail.
