On the 11 day of JUNE 20 18 at 1600  AM  PM

On June 11, 2018 I, Agt. Laufer was on patrol in unincorporated Boca Raton, Florida. At approximately 15:36 hours I observed a white Chevy four door pickup truck change lanes with out utilizing his turn signal. D/S Korb was also in the area during the infraction. D/S Korb then initiated a traffic stop by turning on her red and blue lights in her marked PBSO patrol vehicle. The traffic stop was done in the Westbound lanes of Glades Road at Boca Lake Dr. D/S Korb approached the vehicle and made contact with the driver. The driver, a white male, identified as Tate Lindsey DOB 11/18/1960 was the sole occupant of the vehicle. While D/S Korb was speaking with LINDSEY, she asked him if she could search the vehicle. LINDSEY then gave consent to search the vehicle.

During the search of the vehicle I was informed by D/S Korb that when she approached the driver side bed of the truck she could smell marijuana. I went over to the vehicle where I opened the unlocked tool box. I could also smell fresh, unburnt marijuana. As I opened the tool box I could see a plastic bag containing a green leafy substance, known to me from my training and experience to be marijuana. I took a photograph of the bag of marijuana in the tool box.

I then advised D/S Korb to place LINDSEY under arrest. As I said I was going to tow the truck. LINDSEY asked if I could just park the truck in the shopping plaza we were in front of. I then moved the vehicle and locked it with out incident. I then took possession of the marijuana and headed to the PBSO District 7 substation. D/S Korb transported LINDSEY to the substation. I placed LINDSEY in an interview room. I then read LINDSEY his Miranda rights from a pre-printed card in which he signed and stated he wanted to speak to me about the incident.

This is a summary of our conversation post Miranda: LINDSEY stated he met a guy named Alex who drives a red car, who lives in Coral Springs and, sells marijuana. He also said the bag of weed is his and that he smokes weed. He also stated he bought the ounce of weed for \$240.00.

At this time I find probable cause for the arrest of Tate Lindsey for possession of marijuana over 20 grams in violation of F.S.S. 893.13(6)(a). LINDSEY was issued a traffic citation for the violation for failure to use turn signal.
