<p><b>PROBABLE CAUSE STATEMENT</b></p> <p>I arrived in the area of 95th Way N and Sandy Run Road, in an unincorporated Palm Beach County reference to 911 call of possible home invasion robbery. Tatum Guyer contacted the Sheriff's office via 911 calling system advising that there were three black males in her driveway. One of the black male possibly already in the house and the others were in a car with one having a long rifle. She also said that they were trying to steal her white truck. Note that Guyer later advises that she and the homeowner, James Turner had left the home. They were driving the white truck but left the black males on the property. Several units were enroute with lights and sirens to the location. Contact was later made with the white truck being driven by Turner and the passenger, Tatum at Sandy Run and 95TH Way N. Both Tatum appeared to be hallucinating, agitating and pointing to the back of the truck saying that there was a black male in the back of truck. A visual search of the back of the truck and the trailer that was attached to the trailer showed no black male present. Both subject was told to get out of the truck. Turner gave verbal permission to a search for drugs or weapon. One cut straw was found in Turner's left long jean pocket and a container with a small clear plastic bag containing white powdered substance. Turner voluntarily said that it was Cocaine. He also had a pill bottle containing 1 of Alprazolam 2mg and approximately 5 Oxycodone 30mg. Turner also said that he and Guyer had been doing Cocaine and Xanax which is why they are acting this way. Turner was placed under arrest for possession of Cocaine, schedule II and schedule IV. Guyer was also placed under arrest for misuse of 911. This case was cleared by arrest.</p>
