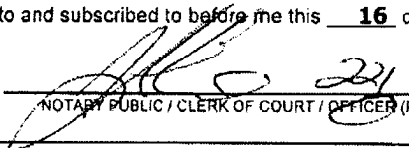

together at 153 Banyan Circle approximately three years ago.

Prior to the drop off of Penny, Taylor and Kyle were exchanging text messages about upcoming timesharing issues with Penny. Kyle stated that per his current Florida court order regarding timesharing; he was supposed to have Penny on 10/16 at 1700 hours. He said that Taylor was refusing to drop Penny off unless he agreed in writing to grant Taylor extra timesharing during the weekend, so Penny may attend an event. He showed me text messages confirming the disagreement. He was not able to produce a copy of the timesharing agreement.

Kyle stated that Taylor initially arrived at his home around 1715 hours with Penny, and parked just down the street. She continued to (via text) tell him that she would not release Penny to him unless he promised to grant her extra timesharing on the weekend for an event. Kyle then walked outside and saw Taylor parked down the road. She drove away at a high rate of speed when he walked outside.

Taylor came back shortly after, and walked through the front door of Kyle's home with Penny, without knocking, and Penny ran inside into the living room.

Kyle immediately told Taylor that she may not be in his residence, and that she needed to leave. Taylor refused to leave, and demanded that Kyle grant extra timesharing, or she would take Penny back.

She then tried to get Penny to come back to her in the doorway. Kyle continually told Taylor to leave or he would call the police, and she refused to leave without Penny. Taylor tried to guide Penny back out of the door to leave, and Kyle held the door partially closed, preventing Taylor from coming further into the home.

During the altercation, Taylor began punching Kyle in the face (three times) with a closed fist as he held the door. He then pushed it shut and she left.

I observed redness and swelling on the left side of Kyle's face. There was a scratch on the upper portion of his left arm, and he declined medical attention. Photos were taken and placed into the Jupiter Police Dept. evidence facility.

I spoke with Penny and she was in good spirits. She did not appear to have any injuries. Photos of her and Kyle were taken on scene. Kyle completed a sworn statement via body worn camera.

I then went to Taylor's home at 408 Georgian Park Drive, Jupiter FL 33458. I made contact with her and told her that I needed to speak with her about the altercation with Kyle. She immediately asked if she was going to jail.

Upon speaking with Taylor, she confirmed that there was an altercation at Kyle's home, and a disagreement over timesharing. She told me the following: Kyle is manipulative, abusive, and she is scared of him. Taylor initially parked down the road at his residence to drop off Penny, and she became frightened when he came outside and ran toward her vehicle, so she drove away. She then came back shortly after and was invited into the home. Penny was upset and crying, so she tried to console her in the doorway. Kyle told her to leave and threatened to call the police, so she willfully left the home. She did not strike Kyle in any way, and he did not hit her.

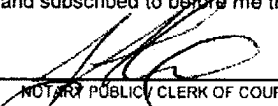
I did not observe any redness or injuries on Taylor, and she stated she wasn't injured. Taylor smelled like alcohol and stated she only had a few sips of wine after getting home from work.

N A R R A T I V E	Based upon my investigation I determined there was probable cause to arrest and charge Taylor Baird with domestic battery. Kyle was issued a Domestic Violence victim's rights brochure. She was placed into handcuffs which were checked for proper spacing and double locked. She was searched incident to arrest by Officer Raleigh with negative results for contraband. Taylor was transported to the Jupiter Police Dept. for processing, and then to the Palm Beach County Jail without incident. The Department of Children and Families was notified of the incident. Body worn camera was used for the duration of this incident. The above listed events are a summary of the body worn camera footage, and not purported to be verbatim. Based upon the above aforementioned facts I find probable cause to charge Taylor M. Baird with Florida Statute 784.03(1) DOMESTIC BATTERY.
